Subject could not discuss over telephone, but was asked to travel to D.C. in 2 days. Subject stated he could not but that information too hot to let ~~you~~ alone.

Subject contacted 3:45 and said information involved Victor Espinosa who was presently in N.Y. + worked for agency - had just returned from Paris and Spain + had to see someone from the Agency.

Subject gave Espinosa address as 415 East 52<sup>nd</sup> St. NYC + phone as HA1-7875.

Subject called again 1615 to say Espinosa at home + suggested someone call him.
