The document will be retrieved from identity upon his arrival at Headquarters and will be returned separately to CCS. 16-29

3. Records available¹⁰ in L.A. Division also reflect that identity was issued a (Maryland) Driver License in the alias of 07 Miguel P. COSSIO and a (Florida) Driver License in the alias of 07 (Diego S. MARDONES). These two documents were reportedly returned to the Office of Technical Services in April 1974.
