Investigation reflects that BOSCH has a friend or representative of his organization in Panama, name and address unknown. Circumstances indicate that BOSCH may have telephoned or cablegraphed this individual on or about 7 July 1968, from Miami, Florida, requesting that the above-quoted telegram be transmitted.

3. Headquarters received the above information from LMERGO accompanied by a request to initiate appropriate inquiries in Panama City in an effort to determine the sender of the aforementioned transmission and also to discover if Orlando BOSCH Avila or one of his immediate associates may have been responsible for having this message sent. LMERGO cautioned that its role as the source of the above information should not be revealed in making the requested inquiries, though the data itself could be utilized.

4. If feasible, it is requested that JACOBRA check its sources and report any information which connects BOSCH or any of his associates with the transmission of the above-quoted telegram.

JMWAVE - LHMGO Report (LHM-21617) possible bombing of a plane from Havana to Cuba.

The following paragraphs were extracted from a detailed report on the activities of Dr. Orlando BOSCH Ariza, a Cuban medical doctor and head of the anti-Castro revolutionary organization, MIRA, and resident in the U.S.:

"On June 10, 1968, ME T-3 reported that BOSCH claims to have a man now in London, Robert Islands, who is checking British flights used by Cuban United Nations personnel traveling from New York City to Cuba. ME T-3 expressed the belief that this procedure is a preliminary survey to some form of action, possibly the bombing of a plane going from Havana to Cuba with Cuban United Nations personnel aboard.

"On June 17, 1968, ME T-3 reported that BOSCH had declared that he intends to continue bombing ships of countries trading with Cuba. On June 19, 1968, BOSCH disclosed to ME T-3 that he has men in New York City, Tampa and Miami who are checking out BOSCH's plan to bomb ships."

THE ALLEGED PERSON ON MARCH TWENTYTWO, SIXTYSEVEN, AGAIN CALLED AND CLAIMED THAT THEIR TARGET WOULD BE PUNTO ALLEN, CUBA. FOUR TO SIX BOMBS WOULD BE USED. THE RAID WOULD BE WITHIN TWO WEEKS. A TWIN ENGINE AIRPLANE WOULD BE USED. THE FLIGHT WOULD BE OUT OF OPA-LOCKA, FLA. AND THE PILOT WOULD RECEIVE BETWEEN FIFTEEN HUNDRED AND TWO THOUSAND DOLLARS.

A SECOND SOURCE, WHO HAS BEEN ASSOCIATED WITH BOSCH IN THE PAST AND WITH WHOM INSUFFICIENT CONTACT HAS BEEN MADE TO DETERMINE HIS RELIABILITY, ON MARCH TWENTYNINE, SIXTYSEVEN, FURNISHED THE FOLLOWING INFORMATION.

ON FEBRUARY TWENTYTWO, SIXTYSEVEN AND MARCH TWELVE, SIXTYSEVEN, BOSCH MET WITH AN AMERICAN PILOT CONCERNING A BOMBING MISSION OVER CUBA. BOSCH SAID THAT BETWEEN THIRTYFIVE HUNDRED AND FOUR THOUSAND DOLLARS WOULD BE USED TO FINANCE THE RAID, A RENTED AIRPLANE WOULD BE ACQUIRED FROM OUTSIDE FLORIDA, A PILOT AND TWO OTHERS WOULD CARRY OUT THE MISSION, AND THAT BETWEEN FOUR AND SIX ONE HUNDRED POUND BOMBS WOULD BE USED. THE TARGET WOULD BE A SUGAR MILL ON THE NORTH COAST OF CUBA.

THIS SOURCE REPORTED THAT BOSCH IS VERY SECURITY CONSCIOUS, WOULD NOT IDENTIFY THE CREW OF THE AIRPLANE, THE SOURCE OF THE

DONES, OR FROM WHERE IN THE UNITED STATES THE PLANE WOULD TAKE OFF.

BOSCH SAID HE WOULD CONTACT THE PILOT ON APRIL ONE, TWO OR THREE, SIXTYSEVEN, EARLY MORN ON THE MISSION, FINALIZE ALL ARRANGEMENTS, AND THE PILOT WOULD BE READY TO LEAVE AFTER THE BRIEFING. BOSCH INDICATED THE PILOT AND CREW WOULD NOT KNOW EACH OTHER'S IDENTITIES OR THE DESCRIPTION OF THE AIRCRAFT UNTIL THE TIME OF THE MISSION.

U.S. CUSTOMS IN MIAMI, FLORIDA, ADVISED THAT IT IS CONDUCTING INVESTIGATION IN THIS MATTER. ACCORDINGLY NO INVESTIGATION IS BEING UNDERTAKEN BY FBI.

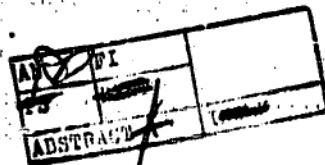

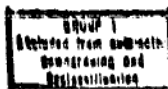

With regard to the statement made by Orlando BOSCH Avila, director of the MIRR, on 4 June 1966 at the trial going on in Orlando, Florida to the effect that the CIA had encouraged him to set up an attack against a refinery in Cuba (see the attached copy of the item in Diario Las Americas on 5 June) we have the following to report.
2. On 30 April 1966 BOSCH told P-86 during a conversation (see DD-1648, para. 9) that he intended to involve the United States in his plans, and using this form of blackmail against the authorities of the United States.

El proceso ante un tribunal federal, que se sigue asimismo a otros tres exiliados cubanos (Marcelo Rodríguez, José Díaz y Gerardo Gutiérrez, deberá culminar mañana con la entrega del caso a un tribunal de 12 miembros.

Bosch declaró que en tal día Johnson, a quien identificó como agente de la CIA, le propuso bombardear desde el aire la refinería, para lo cual le prometió un avión, un piloto y las bombas. Añadió haber convenido el traslado de los explosivos a la casa de Frank Swannar, el piloto que atestigüó, por la fiscalía, que los reos intentaron contratarlo para la explosión aérea.

El acusado dijo a los abogados del gobierno que no intentaba infringir las leyes estadounidenses de neutralidad y exportación de munición, pues el plan fue concebido por la CIA.

Mientras los acusadores señalan que Bosch fue advertido sobre las normas federales, sus defensores abogan que el Gobierno Federal proporcionó los materiales y había contratado a Johnson.

El abogado defensor argumentó que la incursión no iba a ser realizada desde territorio de Estados Unidos, y que las bombas que debían utilizarse no estaban clasificadas como armamentos bélicos.
