1. IN INITIAL DISCUSSION WITH IDEN A, HE INFORMED KARNLEY THAT HE IS IN CONTACT LOCALLY WITH DRE (FOR DIR: SEE PARA 1 REF). IDEN A SAID HIS CONTACT HAS BEEN WITH JOSE ARTECONA, BROTHER OF CARLOS "TRIPA" ARTECONA.
2. ARTECONA HAD SOUGHT IDEN A'S ASSISTANCE OBTAINING MINIATURE CAMERAS WHICH SAID HE WISHED TRANSMIT TO PBRUMEN THROUGH CHANNEL WHICH HIS ORGANIZATION HAS NOW ESTABLISHED WITH IDEN B. ACCORDING TO ARTECONA IDEN B COOPERATING AS COMMUNICATIONS CHANNEL USING **"DIPLOMATIC POUCH"** AND HAS NOT ONLY TRANSMITTED MESSAGES BUT ON ONE OCCASION TRANSMITTED ONE UNIT SMALL ARMS.
