1. PROBLEM OF ROBERTO DE VARONA BECOMING ACUTE AS INDICATED FOLLOWING PARAGRAPHS.
2. ORRISON REPORTED INFO FROM LITAIN-5 29 SEPT 60 THAT VARONA RENTED AND FURNISHED INDEPENDENT OFFICE ON CALLE INDEPENDENCIA HANDLE AMHAWK AFFAIRS. L-5 SAID IMPOSSIBLE FOR ANYONE TO WORK WITH VARONA, EVEN AMHAWK HIMSELF, WHICH IS WHY AMHAWK FUNDS HIM 2000 DOLLARS PER MONTH MEXI. WITH THESE INDEPENDENT FUNDS LITTLE CAN BE DONE MEXI RESTRICT HIS INDEPENDENT REPRESENTATION AMHAWK ALTHOUGH THIS PLUS HIS REFUSAL ADHERE DEMARCATION WIPES WORK MEXI DELEGATES MAKES FOR CONTINUAL DISSENSION. 5. ON 5 OCT SHYROCK ⁹ AND GESTETNER ¹⁰ DEBRIEFED MR. [WILLIAM FELDER,] ⁴ AMERICAN BUSINESSMAN MEXI, RE CONTACTS WITH ROBERTO DE VARGA ⁴ AND AMHAWK. ROBERTO TOLD [FELDER] ^{D6} AND [HUGH MONTAGUE,] ^{D6} APPARENTLY BRITISH FRIEND [FELDER,] ⁰⁶ HE WANTED TRAINING BASE MEXI FOR CUBAN EXILES. ^{A13C}
