James A. PERRY

James A. PEFRY, Jr., mailed two letters from Washington, D. C., on 29 June 1955, one to his father, and another to Severino D. COMEZ; however, in so doing, PEFRY placed the letter to his father in the envelope addressed to COMEZ, and the letter to COMEZ in the envelope addressed to his father. When the letters were received by PEFRY, Sr. and COMEZ, both noting the error, they exchanged letters. However, COMEZ considered the contents of the letter he had at first received important enough to turn over to his brother M. Leal GOMEZ, who in turn referred it to the Boston Office of the FBI.

The letter, in substance, indicated that while PERNY was serving in South America, under cover for this Accept, he had revealed his true status to his wife's father, have GONSALVES, on a visit to South America, and who later had revealed this information to PERNY's father.
