1. ON 12 SEPTEMBER 1977 THE LOCAL PEACE CORPS DIRECTOR (PCD) TOLD THE COS THAT ONE VICTOR P A N E O U E BATISTA APPROACHED A VOLUNTEER IN BLUEFIELDS, NICARAGUA, IDENTIFIED HIMSELF AS A "CIA OPERATIVE", AND ATTEMPTED TO RECRUIT HER AS AN INTELLIGENCE AGENT. THE PCD SAID THE RECRUITMENT ATTEMPT WAS MADE AROUND 29 AUGUST 1977.

2. THE PCD SAID THAT THE VOLUNTEER FIRST MET PANEQUE WHEN SHE WAS ASSIGNED TO BLUEFIELDS IN APRIL 1977 AND RENTED A HOUSE FROM HIM. THE PCD ALSO SAID PANEQUE DRINKS HEAVILY AND THAT WHEN HE IS DRUNK HE TELLS PEOPLE HE IS A "CIA AGENT" AND A BAY OF PIGS VETERAN.

4. THE STATION HAS TWO CARDS ON AN INDIVIDUAL WITH THE ABOVE NAME:

- A. THE SUBJECT OF 201-2286382 - MANAGUA 00364,
11 APR 1973, NO LONGER AVAILABLE IN STATION FILES.
- B. IDENTIFIED AS A CUBAN CITEZEN AND THE "SOURCE
