KEYWAY PERUMEN AMWHIP

1. AMWHIP/1 (IDEN A), LONG TIME KUBARK ASSET FOR PERUMEN OPS, WILL VISIT ROME 5 TO 15 JUNE TO OPEN JEWELRY STORE IN IDEN B. HAS OFFERED BE OF SERVICE TO STA IN ANY WAY POSSIBLE INCLUDING FURNISHING COVER IN NEW STORE. THOUGH LEFT PERUMEN EARLY 1961, REMAINS PERSONA GRATA TO REGIME SINCE GAVE AID TO CURRENT REGIME DURING PRE-REVOLUTION DAYS AND TOOK NO OVERT OPPOSITION STAND. IS CONSIDERED BY CURRENT REGIME AS A POLITICAL BUSINESSMAN AND CAN ENTER OFFICIAL INSTALLATIONS MEET WITH PERUMEN DIPLOMATS. FOR EXAMPLE, PLANS RENEW PERUMEN PASSPORT AT EMBASSY, PARIS, ON CURRENT TRIP.

POSSIBILITIES, INCL COVER FOR PERUMEN OPS SUPPORT ASSET AS PLAINED. IF COVER
FOR SUBJ DIR 38810 STILL UNRESOLVED, STA SHOULD RAISE PROBLEM WITH AMWHIP/1,
