ON 29 SEPT 77 AT 1830 HOURS LOCAL ONE GARY VAN DYK, WHO IDENTIFIED HIMSELF AS A BRITISH SUBJECT WHO WAS BORN IN JOHANNESBURG, SOUTH AFRICA ON 25 MAY 1936 AND WHO SAID HE IS A LITERARY AGENT BY PROFESSION AND RESIDES AT 62 REDKNOLL WALK, CHELSEA, SW-3, LONDON WALKED INTO U.S. MISSION, SUBJECT WHO IS STAYING AT HOTEL AMAT IN GENEVA ORIGINALLY CONTACTED DCM SORENSON WHO ASKED THAT COS INTERVIEW HIM.

A. IN JUNE 1977 FRANK STURGIS (PRESUMABLY SAME PERSON OF WATERGATE FAME) CAME TO LONDON AND CONTACTED AN UNIDENTIFIED MEMBER OF FNLA. THROUGH LATTER, STURGIS

SUPPORT (ACCORDING TO SUBJECT FROM SOME LATIN AMERICAN
GOVERNMENTS) AND AGREED AS TO WHO THE NEW MEMBERS OF THE GOVERN-
MENT IN EXILE (I.E. ANGOLA) WOULD BE.

D. GIPENDA, WHO AT THE TIME WAS IN LONDON, WAS SUSPICIOUS
OF STURGIS BUT WENT ALONG WITH FERNANDEZ GETTING HELP FROM
STURGIS. GIPENDA THEN WENT TO GENEVA WHERE HE HAS BEEN EVER

TO SUBJECT, TO SPEAK TO MOBUTU, WHO AS HQS KNOWS IS CURRENTLY IN SWITZERLAND. SUBJECT SAID THAT THE GIPENDA/MOBUTU TALK WILL TAKE PLACE IN NEXT FEW DAYS.

E. MEANWHILE GIPENDA AND SUBJECT AND POSSIBLY OTHERS HAVE RUN UP A 60,000 FRANC (US\$ 25,222) HOTEL BILL AT AMAT HOTEL AND EVIDENTLY THE HOTEL MANAGEMENT PLANS TO CALL THE POLICE IN THE NEXT DAY OR SO IF BILL IS NOT PAID.

F. SUBJECT BROUGHT WITH HIM A FILE OF XEROXED DOCUMENTS IN A LOOSE LEAF NOTEBOOK WHICH HE FLEETINGLY EXHIBITED. THERE WERE SEVERAL PHOTOS OF SUBJECT IN CAMOUFLAGED JUNGLE DRESS IN A JUNGLE, A PHOTO OF A PERSON SIMILARLY DRESSED WHOM SUBJECT IDENTIFIED AS FERNANDEZ AND LISTS OF EQUIPMENT AND OTHER MATERIAL WHICH SUBJECT SAID WAS SENT BY SOVIETS TO CUBAN FORCES IN ANGOLA. ACCORDING TO SUBJECT, THIS INTELLIGENCE WAS SENT OUT BY MPLA MEMBERS STILL IN ANGOLA.

G. SUBJECT SAID THAT ANOTHER COUP AGAINST ANGOLAN GOVERNMENT IS CURRENTLY BEING PLOTTED AND, IF SUCCESSFUL, PLOTTERS WANT GIPENDA TO BE THE NATIONAL LEADER AND NOT HOLDEN ROBERTO. SUBJECT APPEARS STRONGLY ANTI-HOLDEN ROBERTO AND SAVIMBA.

H. SUBJECT DID NOT MAKE ANY PITCH FOR MONEY OR ANY OTHER REQUEST BUT SAID HE WOULD LIKE SOMEONE FROM WASHINGTON WHO WAS FAMILIAR WITH ANGOLAN MATTERS TO COME TO GENEVA SOONEST TO SPEAK WITH GIPENDA IF WE WANTED TO LEARN MORE.

3. IN RESPONSE TO COS' QUESTION, SUBJECT SAID HE WAS NOT A MERCENARY BUT HE WANTED AS A FORMER SOUTH AFRICAN TO SEE CURRENT ANGOLAN REGIME THROWN OUT ALONG WITH THE CUBANS. IN SPITE OF SUBJECT'S STATEMENT THAT HE DOES NOT WANT ANY MONEY OR DID HE COME TO MISSION TO SELL INFORMATION, IT IS OBVIOUS SUBJECT AND GIPENDA ARE OUT OF MONEY. SUBJECT WENT TO EXCEPTIONAL LENGTHS TO BE ASSURED THAT ABOVE INFORMATION WOULD NOT LEAK. HE APPEARS TO BE A VERY WELL-EDUCATED, COHERENT, SOFT-SPOKEN INDIVIDUAL IN SPITE OF THE FOREGOING STORY. HE IS ABOUT 6 FEET THREE INCHES TALL, 210 POUNDS, DARK BROWN HAIR WORN STYLISHLY LONG, LONG FACE, CLEAN SHAVEN, SMOKES BRITISH CIGARETTES, AND SPEAKS WITH EITHER A SOUTH AFRICAN OR AUSTRALIAN ACCENT.

SUBJECT: LORENZ, Llona Marita

1. As the result of an article on Subject in the 13 June 1976 New York Daily News, LA/OOG was asked to do a file check to determine whether Subject was ever connected with the Agency. According to a LA/OOG desk check, IP trace, CI/OA and Security Office check, LORENZ has never been employed by the Agency. Of interest, however, is the fact that her sister, Valerie LORENZ, was granted a CSC on 14 July 1955, initiated by Finance Division, as a witting employee. At that time Valerie was an employee of the National Bank of Washington.

2. There are several references, sourced to the FBI and DOD. LORENZ is a self-admitted former girl friend of Fidel CASTRO. She claims that she met Fidel while on a trip to Cuba with her father, Captain of the North German Lloyd Line, in February 1959, became infatuated with Fidel and stayed in Cuba. She served as Fidel's mistress and came to the U.S. with Fidel's party in April 1959. She learned at that time that she was pregnant by him. Marita returned to Havana a short time thereafter and had a miscarriage. She claims that she was drugged and taken to a hospital where an abortion was performed. Because of Fidel's reaction to the pregnancy, she turned against him. LORENZ returned to the U.S. from Cuba on 9 December 1959. Because of the bad abortion operation performed on LORENZ in Cuba in September 1959, LORENZ was operated on by a Dr. Hanniar on 20 January 1960 at the Roosevelt Hospital in New York City.

3. It is said that LORINZ appeared on the Today's Show on 14 June 1976. She reportedly made the statement that she was associated with Frank STURGIS, and that she had placed some poison pills in her face cream for the purpose of assassinating Fidel. A 24 April 1961 FBI document states that on 8 January 1961 LORENZ, STURGIS, Alex RORKE were to meet that evening and attempt a unity meeting of anti-Castro Cubans. The unity meeting was sponsored by Luis CONTE Aguero, one of the leading anti-Castro Cubans. I have uncovered nothing to date concerning an assassination attempt (in this connection.)

1. According to a source of the Miami Field Office of the Domestic Collection Division, Subject disclosed to the source the following information concerning plans which allegedly reflect Subject's interest in Africa and Panama in conversations held on or around 5 June 1977. Subject has discussed plans to establish a Cuban Government in exile on Angolan soil with the help of Holden ROBERTO, FNLA. Subject is prepared on receipt of agreement from Roberto to provide food, medical teams and other forms of assistance to the FNLA. Ostensibly, this would be a first step following recognition by Roberto of a Cuban Exile Government. This government would then attempt to raise troops and, among other things, capture as many Castro soldiers as possible in order to use them as an exchange or trade instrument. The funds for such an enterprise ostensibly would come from Cuban Communities in Brazil, Nicaragua, Panama, Mexico, Venezuela and the United States. One aspect of the proposed unconventional war is the use of counterfeit Angolan money. Also allegedly involved is planning to secure Angolan aid for Panamanians who oppose Torrijos.

2. Involved in unspecified ways in these plans are the following:

STURGIS HAD TOLD MORGAN THAT HE HAD JUST RETURNED TO MIAMI FROM NEW YORK CITY, WHERE HE HAD BEEN INTERVIEWED FOR THE "TOMORROW SHOW" ON NBC. (THIS INTERVIEW WAS SUPPOSED TO HAVE BEEN TELEVIEWED AT 0100 HOURS, 24 AUGUST, BUT WAS NOT.)

2. STURGIS SAID THAT WHILE IN NEW YORK HE HAD STAYED THE WEEKEND (PRESUMABLY 21 AND 22 AUGUST) WITH MARITA LORENZ, WHO STURGIS SOMETIME AGO PUBLICLY CLAIMED TO HAVE HIRED TO POISON CUBAN PRIME MINISTER FIDEL CASTRO. LORENZ GAVE STURGIS A BOOK CONTAINING CRYPTOGRAPHIC MATERIAL THAT SHE SAID SHE HAD STOLEN FROM THE ALBANIAN MISSION IN NEW YORK. MORGAN WAS SHOWN MACHINE COPIES OF THREE OR FOUR PAGES OF THIS MATERIAL, WHICH CONSISTED OF FIVE DIGIT NUMERICAL GROUPS IN SERIES ACROSS THE PAGES. EACH OF THE GROUPS HAD A SINGLE LINE DRAWN THROUGH AS IF A DECODING OPERATION HAD BEEN PERFORMED. STURGIS TOLD MORGAN THAT HE HAS DISTRIBUTED PAGES OF THE BOOK IN VARIOUS PLACES IN MIAMI FOR SAFEKEEPING UNTIL HE CAN TURN ALL OF IT OVER TO SENATOR HOWARD BAKER. TO THIS END HE ALREADY HAD PLACED A CALL TO BAKER'S STAFF ON 23 AUGUST. STURGIS TOLD MORGAN THAT LORENZ HAD GIVEN HIM THE BOOK BECAUSE ONE OF HER MAFIA CONTACTS IN NEW YORK TRIED TO BLACKMAIL HER (FOR SOME REASON UNKNOWN TO MORGAN OR OURSELVES), AND SUBSEQUENTLY BEAT HER SEVERELY AND THREATENED HER LIFE. AS A RESULT, SHE NO LONGER WANTED ANY PART OF THE CRYPTOGRAPHIC MATERIAL IN QUESTION. STURGIS PROMISED TO GET IT INTO OFFICIAL U.S. GOVERNMENT HANDS.

MEMORANDUM FOR THE RECORD

SUBJECT: Call from **Jon French** of DCD Concerning Frank STURGIS.

1. The following information was provided to **Jon French** by his DCD Miami office on 23 August. The information was given to the DCD Miami office by a contact (not identified) on 23 August who obtained it from Oscar FREELY. FREELY is writing a book on Frank STURGIS.

2. STURGIS is to appear on the Tomorrow Show at 2 a.m. on 24 August, which is to be narrated by Tom Schneider. STURGIS just recently returned to Miami from taping the show in New York.

3. While in New York STURGIS saw Marita LORENZ and obtained from her a book which, according to source, appeared to be cryptographic material and seemed to relate to Albania. The DCD source saw a "few copies" of what he described as "mathematical matrix" material.

4. STURGIS currently (today - 23 August) is attempting to contact Senator Baker to turn over the material to him. DCD plans to ask the source to monitor the situation and advise whether the material in fact is turned over to Baker.

A CONFIDENTIAL SOURCE WHO HAS FURNISHED RELIABLE INFO IN THE PAST AND IS KNOWLEDGEABLE CONCERNING CUBAN EXILE ACTIVITIES IN MIAMI ADVISED THAT CARLOS PRIO SOCARRAS, EX-PRESIDENT OF CUBA, AND CAPTAIN EDUARDO SOTOLONGO, DR. CARLOS PRIO SOCARRAS WAS THE SPOKESMAN FOR THE GROUP AND HE ASKED JACK ANDERSON TO HELP THE CUBANS UNITE UNDER ONE COMMON GOAL, THE LIBERATION OF CUBA. JACK ANDERSON REPLIED THAT HE WOULD ASSIST CUBAN UNIFICATION IN THE U.S., BUT WOULD NOT WRITE AGAINST CO-EXISTENCE.

SOURCE ADVISED ABOVE MEETING WAS HELD SOLELY FOR THE PURPOSE OF OBTAINING SUPPORT OF JACK ANDERSON IN UNITING CUBAN EXILES IN THE UNITED STATES. NO DISCUSSION WAS HELD CONCERNING BOMBINGS OR OTHER TERRORIST ACTIVITIES AND THESE MATTERS WERE NOT ALLUDED TO DURING THE MEETING.

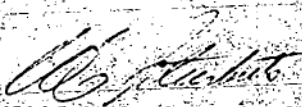

SUBJECT: Frank Anthony STURGIS (201-242256)

1. This morning I received a phone call from the COS, Miami who advised me that yesterday Frank Sturgis called the DCD, Miami Office, and expressed a desire to meet with one of the DCD officers. Sturgis claimed to have new information on the movement of narcotics through Mexico and other information which he did not specify.

The DCD Miami Office thanked Sturgis for calling and referred him to the FBI and DEA, who would be the most interested recipients of the information he has. Sturgis was very pleasant on the telephone and the DCD people obviously responded correctly.

Cubanos Unidos (CU) is a Cuban exile anti-FIDEL CASTRO organization in Miami, Florida. Its purpose is to unite all exile groups into a unity organization and begin military operations against the present Government of Cuba.

WILFREDO NAVARRO BEATO is the head of CU, which organization now maintains office space at 1996 S. W. 1st Street, Miami, telephone 642-9741.

On June 9, 1970, MM T-1, a Cuban exile involved in revolutionary matters for the past six years, advised that CU recently decided to start selling bonds issued in the name of the Republic of Cuba. The money collected would be used to purchase arms for proposed military operations against Cuba.

On June 15, 1970, MM T-1 stated that WILFREDO NAVARRO at that time was claiming that MAURICE FERRE, member of the Miami City Commission, is assisting him in Cuban revolutionary activities. NAVARRO claimed that about a week previously, a meeting was held in the FERRE Building in Miami, and it was determined that CU had adequate money resources. NAVARRO said that he instructed TOMAS ARENCIBIA, a leading member of CU, to quit his job and NAVARRO would pay his salary. NAVARRO explained that he wanted ARENCIBIA to work on a full-time basis for CU. Also present at this meeting were three unidentified Americans, one of whom reportedly has a quantity of arms stored at his house.

On June 19, 1970, MM T-3, another Government agency which conducts intelligence investigations, advised information had been received that CU recently held a meeting to introduce Americans who are backing their organization. The Americans were FRANK FIORINI and ED KAISER. FIORINI calls himself the "Chief of Intelligence Section of Cubanos Unidos".

On July 1, 1970, WILFREDO NAVARRO BEATO appeared at the Miami Office of the FBI with his brother, ROERME NAVARRO BEATO, and advised as follows:

FRANK FIORINI, an American citizen who has been involved in Cuban exile revolutionary matters for the past ten years, recently signed a unity agreement with CU. In this agreement, FIORINI, who represents some independent anti-CASTRO organization, agreed that political unity of all exile groups must be established. FIORINI is not a member of CU as such, holds no official position, and is not in charge of intelligence.

NAVARRO said that a few days previously he returned from Washington, D. C., where again he was trying to obtain United States Government support and backing. He was told that no support could be given unless it was personally authorized by President RICHARD M. NIXON.

They stated that JORGE CONZALEZ, also known as "Bombillo", who was formerly associated with another anti-CASTRO organization, was in no way associated with CU. They claimed that CU had no plans to attack a Russian vessel off the coast of Florida. CU had previously said it needed some 57mm recoilless rifles for this purpose but had no intention of attacking a Russian vessel. Announcements that they were going to do so were made for political propaganda and also to stir patriotic Cuban exiles to become more active in Cuban revolutionary matters.

NM T-5 indicated that it was intended that mercenaries from Corsica would be used.

On July 29, 1970, EDWIN BENJAMIN KAISER, JR., 805 West 30th Street, Hialeah, Florida, advised that he knew no one named BOB RAHEY or (First Name Unknown) RODRIGUEZ ALONSO. KAISER said that he had previously been in the French Foreign Legion and knows former legionnaires who now live in all parts of the world. Many of these legionnaires would fight as mercenaries if contacted, but at the present time neither he nor CU has any plans to contact these people and does not have the funds to pay them or the military equipment to issue them. KAISER said that WILFREDO NAVARRO is a long-time friend of Miami City Commissioner, MAURICE FERRE, and the nature of their relationship is business interests.

KISSINGER'S VISIT IN VENEZUELA WHICH WOULD TEND TO DISCREDIT HIM AND THE PRESIDENT OF VENEZUELA.

AS A RESULT OF THESE REPORTED DISCUSSIONS, THE SOURCE HAD BEEN LED TO BELIEVE THAT POSSIBLY THESE PLANS MIGHT RESULT IN AN ASSASSINATION ATTEMPT ON KISSINGER WHEN HE WAS VISITING IN VENEZUELA.

STURGIS EXPLAINED THAT THIS SOURCE WAS UNABLE TO FURNISH ANY OTHER DETAILS IN CONNECTION WITH THIS INFORMATION AND NO OTHER MEMBERS OF THE GROUP WERE IDENTIFIED. STURGIS UNDERSTOOD THAT THE SOURCE HAD OBTAINED THE INFORMATION ABOUT THE ALLEGED PLANS FOR CREATING AN INTERNATIONAL INCIDENT INVOLVING KISSINGER THIRDDHAND. THE WIFE OF A MAN WHO WAS CONNECTED WITH A MEMBER OF THIS GROUP HAD OVERHEARD HER HUSBAND TALKING ON THE TELEPHONE ABOUT KISSINGER'S VISIT TO VENEZUELA AND HAD REPORTED THIS INFORMATION TO THE SOURCE.

STURGIS ADVISED THAT NOW THAT KISSINGER'S VISIT TO VENEZUELA HAD BEEN CANCELLED, HE UNDERSTOOD THAT ALL PLANS "HAD BEEN ABORTED" AND THAT THERE WAS NO IMMEDIATE DANGER OR CONCERN, ALTHOUGH NO DEFINITIVE PLANS OF THE GROUP WERE KNOWN. STURGIS UNDERSTOOD THAT THE GROUP HAD ONLY DISCUSSED POSSIBLE PLANS FOR AN INCIDENT INVOLVING BOTH KISSINGER AND THE PRESIDENT OF VENEZUELA DURING SUCH A VISIT IN ORDER TO DISCREDIT UNITED STATES-VENEZUELA RELATIONS.

STURGIS POINTED OUT THAT THE CUBAN EXILES ARE ALWAYS TALKING, CONSPIRING AND PLANNING SOME SORT OF ANTI-CASTRO ACTIONS, BUT IT IS PRIMARILY IDLE AND HOPEFUL GOSSIP AND RUMORS THAT COME TO NOTHING.

STURGIS STATED THAT ALTHOUGH HE FELT THERE WAS NO IMMINENT DANGER IN THESE ALLEGED THREATS, HE HAD PROMPTLY REPORTED THIS INFORMATION TO AN ACCQUAINTANCE OF HIS IN THE U.S. CUSTOMS AGENCY, MIAMI, FLORIDA. THIS U.S. CUSTOMS AGENT HAD ADVISED STURGIS THAT HE WOULD PROMPTLY REPORT THIS INFORMATION TO THE U.S. SECRET SERVICE, MIAMI, WHICH AGENCY HAD PROTECTIVE JURISDICTION FOR U.S. CABINET MEMBERS. ACCORDINGLY, STURGIS UNDERSTOOD THAT THIS MATTER WAS BEING APPROPRIATELY HANDLED BY THE U.S. GOVERNMENT.

SOURCES FAMILIAR WITH CUBAN GROUPS AND ACTIVITIES IN THE MIAMI, FLORIDA AREA HAVE FURNISHED NO INFO INDICATING THE EXISTENCE OF ANY GROUP CALLING ITSELF THE LATIN AMERICAN ANTI-COMMUNIST LEAGUE.

ON MARCH 24, 1975, REVEREND MANUEL ESPINOSA DIAZ, MINISTER
OF THE PENTECOSTAL CHURCH, ACCOMPANIED BY FOUR CUBAN EXILES,
BOARDED THE BOAT "WAHININI II" AT KEY WEST, FLORIDA, WHICH BOAT
WAS PILOTTED BY ANOTHER CUBAN NAMED JOSE CARDENAS. THE GROUP
CLANDESTINELY WENT TO THE NORTH COAST OF CUBA AND REVEREND
ESPINOSA CARRIED A LIST OF OVER THIRTY THOUSAND CUBANS WHO HAD
BEEN UNABLE TO COME TO THE UNITED STATES TO JOIN THEIR RELATIVES.
REVEREND ESPINOSA HAD AN INTERVIEW WITH FIDEL CASTRO IN AN EFFORT
TO ARRANGE THE LEGAL DEPARTURE OF THESE PEOPLE.

SUBSEQUENTLY, ON MARCH 31, 1975, IT WAS LEARNED IN MIAMI
THAT THE "WAHININI II" HAD RETURNED TO MARATHON, FLORIDA, ESCORTED
BY THE U.S. COAST GUARD. ON THE SHIP, IN ADDITION TO REVEREND
ESPINOSA AND HIS CUBAN EXILE COMPANION, WERE TWO U.S. NEWSMEN
AND CAMERAMEN FROM CHANNEL TWO TV, MIAMI, IDENTIFIED AS KY BURTON
AND KAPY KAPERMAN.

The DCD meeting with Sturgis has been cleared with George Carcy, CIA Legal Counsel, and was cleared with the DDO on 25 January 1974. No specific date for the meeting was given to WH, but it is assumed that the meeting will take place within the next few days.
