

AMLASH/1 - Paris Station Aspect

Paris Station involvement with the AMLASH case began in 1962, after AMLASH/1 came to Paris after attending the Helsinki Youth Festival that year. In Helsinki, AMLASH/1 was contacted by UNRUBBLE/2 (an asset of the Paris Station who attended the Festival for purposes of disruption) and by other KUBARK assets. It is not clear from our files just when AMLASH/1 was "recruited" but it appears that he was recruited during or shortly after the Festival.

In Paris he was in contact with Peter J. KYMINGHAM (probably in alias although I know that AMLASH/1 was at KYMINGHAM's home upon occasion). In 1962 AMLASH/1 was given training in explosives by OTHICK (I believe) upon request of the Paris Station. He appears to have returned to PBRUSH in late 1962. It is not known if other Paris Station personnel were in contact with AMLASH/1 during that period.

AMLASH/1 next arrived in Paris on 14 September 1963, coming from the International Games held in Puerto Alegre, Brazil, where he was in contact with TYPIC officers. At this point AMEPORT/1 (now QUESPORT) was in contact with AMLASH/1 in Paris and AMWHIP/1 was another commo channel (the one being used primarily by Hqs.). The Headquarters TYPIC officer, OTHICK (P), arrived in Paris on 3 October 1963 and picked up the contact with AMLASH/1 which was being maintained by AMEPORT/1 and KYMINGHAM. The meetings with AMLASH/1 took place in KYMINGHAM's home as best I remember. These discussions concerned AMLASH/1's plans to assassinate AMPEUD and overthrow his regime.

OTHICK returned to Paris in late October, after discussions at Headquarters on the case. OTHICK and DAINOID, who ^{were} ~~was~~ in Paris at the time, met with AMLASH/1 in late October or early November. DAINOID's participation was due to AMLASH/1 strong desire to talk with some high-level ODYOKE official concerning his plans and to obtain ODYOKE blessing if possible. I am not aware of exactly what happened at these meetings but I received the impression from KYMINGHAM that such blessing was given.

AMLASH/1 returned to PBRUSH on 27 November 1963. It was during this visit to Paris

that STOCKWOOD met AMASH/1 and AMWHIP/1, presumably in alias but I do not know the details. It was also apparent by the time AMASH/1 left that he knew UNSHAFU/5 was working for KUBARK and we know that UNSHAFU/9 was aware to some extent of AMASH/1's plans (UNSHAFU/9 had ~~UNSHAFU/9~~ been recruited by KUBARK at that time). It was agreed that AMASH/1 would use the address of UNSHAFU/13's parents for a/w letters to KUBARK (UNSHAFU/13 is wife of UNSHAFU/9).

AMASH/1 next arrived in Paris in late November or early December 1964. AMWHIP/1 STOCKWOOD and ONTRICH (tdy from Headquarters) met with him in Paris (this time in a safe house of the Station. AMASH/1 left for PERUMEN from Madrid on 20 February 1965. During this stay in Paris AMASH/1 met the following KUBARK staffers and agents:

STOCKWOOD, GLOADEN, RODAMER
AMWHIP/1, UNSHAFU/9, UNSHAFU/5, UNSHAFU/13

You will recall that in December 1964 UNSHAFU/5 had a nervous breakdown and AMASH/1 played an important part in convincing UNSHAFU/5 that he should agree to hospitalization. It was in this connection that GLOADEN and RODAMER met AMASH/1. GLOADEN subsequently met with AMASH/1 two or three times to receive reports for STOCKWOOD. These meetings were street meetings or in the home of UNSHAFU/5. During this stay, AMASH/1 traveled to Madrid at least once to meet with AMEIDDY/1 and AMEANI/1. I am not aware of results of these meetings except that AMASH/1 was seeking the physical instruments to carry out his plan to eliminate ANTRUG.

There was no additional contact with AMASH/1 in Paris subsequent to February 1965 but the Station (GLOADEN and NIKLES) did have subsequent contact with UNSHAFU/5, UNSHAFU/9, AMASH/2 and AMASH/3. You will recall that it was AMASH/3 who made the "joking" pitch to NIKLES on 6 May 1965. AMASH/2 and NIKLES/3 were both aware of AMASH/1 plans.

Paris Station personnel known to AM/138/2

Peter J. KIRKMAN

- not known what alias used. Some meetings were held in KIRKMAN's home in 1962/63. It is not known if other staff personnel (other than ONYX) were met then by AM/138/2.

Paul K. STOCKWOOD

- alias not known for sure but believe he used "Roberts". AM/138/2 knew STOCKWOOD as **ambassador** officer and called him there.

Peter N. GLOANEN

- Known as "Dick". True name not used unless told to AM/138/2 by UNSAFU/5 or UNSAFU/9.

Milton P. RODAMER

- met AM/138/2 only once, when transporting UNSAFU/5 to hospital. Known to all as "Dr." (cant remember aka used).

Dr. Lipsich

- cleared Dr. at American Hospital, Paris. AM/138/2 met him briefly when admitting UNSAFU/5 to hospital.

Wallace A. CROWLEY
(from MARR)

- met in 1962 during explosives training in Paris. Details not known.
