AMLASR/1 - Paris Station Aspent

Paris Station involvement with the AHLASH case began in 1962, after AMASH/1 came to Paris after attending the Helsinki Nouth Festival that year. In Helsinki, AMASH/1 was contacted by UNRUHELE/2 (an asset of the Paris Station who attended the Festival for purposes of disruption) and by other KUBARK assets. It is not olear from our files just when AMASH/1 was "recruited" but it appears that he was recruited during or shortly after the Festival.

In Paris he was in contest with Poter J. KYMINOHAM (probably in alias although I know that AHASK/1 was at KYMINOHAM's home upon cocasion). In 1962 AHASK/1 was given training in explosives by OHEMI (I believe) upon request of the Paris Station. He appears to have returned to PREMEN in late 1962. It is not known if other Paris Station perconnel were in contest with AMASK/1 during that period.

AMELSE/I ment arrived in Paris on It September 1969, coming from the Intermalticinal Games held in Prorto Alegro, Breail, where he was in contact with TIPIC officers. At this point AMERCET/I (now QUEPORT) was in contact with AMELSE/I in Paris and AMMIP/I was another comme channel (the case being meed primarily by Hqs.). The Headquarters TIPIC officer, OMIRICH (P), arrived in Paris on 3 October 1963 and ploked up the contact with AMESE/I which was being maintained by AMERCET/I and EVALUABLE The meetings with AMESE/I took place in EVALUABLE home as best I remember. These discussions concerned AMESE/I's plans to assissingto AMESE and overthrow his regime.

CETRICH returned to Paris In late October, after discussions at Handquarters on the case. Official and Dalletto, who was thy in Paris at the time, and with AMLASH/I in late October or early Howester. DAINOID's participation was due to AMLASH/I strong desire to talk with some high-level ODTOKE official concerning his plans and to obtain ODTOKE blessing if possible. I am not emers of exactly what happened at these meetings but I received the impression from KYMINHAH that such blessing was given.

MLASH/I returned to PREMISEN on 27 Enventor 1963. It was during this visit to Paris
