1. Description:

These files concerned all the support activities for the training and supply of all the infiltration forces in 1960-61.

2. Findings:

a. MASH 1470 (IN 38669) 6 Nov 60:

The deputy of Manuel ARTIME (AMBIDDY-1) reported that (Eduardo OJEDA Camaraza) had contacted AMYUM/AMRUNG complex in Havana for help in accomplishing mission and if his bona fides were not established AMRUNG/AMYUM may arrange to kill (OJEDA) as he was either very untrustworthy or positive CASTRO penetration/provocateur.

b. RIMM 5846, 4 June 1961:

Radio message received from agent # 84 "Functionary Italian Embassy by the name of MORATORI says
he works for one intelligence org. of yours, he says he is
in contact with Martin Elena and others and that you have
plans for invasion within 30 days after killing Fidel,
advise if we can confide in MORATORI."
