1. ACTION REQUIRED: PLEASE CORRECT DRAFT BRIEFING PAPER TO REFLECT CHANGES REQUESTED IN PARA 3, BELOW.

2. RE PARA 2, REF A: THE BACKGROUND OF THE OFFER TO PROVIDE *THE<LEE HARVEY OSWALD>FILES WAS TRANSMITTED TO STATION ON 9 AUG (VIA REF B) THE BOTTOM LINE IS THAT THE MATTER WAS TURNED OVER TO *THE FBI BECAUSE OF THE SENSITIVITY CONNECTED WITH THE<KENNEDY> *<ASSASSINATION...> WE ARE QUERING THE FBI TO SEE WHERE THE MATTER STANDS. YOU ARE WELCOME TO PASS THIS ALONG TO THE AMBASSADOR. WE WILL ADVISE AS SOON AS THE FBI RESPONDS TO OUR REQUEST.

3. PAGES ONE AND TWO OF YOUR BRIEFING PAPER ARE RIGHT ON THE MARK. PAGE THREE HOWEVER CONTAINS SOME ISSUES THAT WE REQUEST YOU DELETE AND/OR SOFTEN.

A. FIRST SENTENCE OF PARAGRAPH 4. DO NOT DISCUSS ANY UNILATERAL OPERATIONS WITH THE SENATOR. WE ARE CONCERNED WITH ANY DISCUSSION OF SOURCES; IN THIS INSTANACE THE CASE IS INACTIVE AND WOULD NOT ADD TO YOUR DISCUSSION.

B. PARAGRAPH 7. PLEASE REDRAFT TO READ AS FOLLOWS: REGARDING EMBASSY SECURITY, OUR CONCERN IS THAT WITHOUT A 24 HOUR PRESENCE WE DO NOT HAVE AN EFFECTIVE DETERRENT TO SURREPTITIOUS ENTRY. ELECTRONIC SECURITY DEVICES WILL ONLY TELL US THAT AN ENTRY HAS BEEN MADE, IT WILL NOT STOP AN ENTRY. SECURITY AT EMBASSY **MINSK** WAS RECENTLY DISCUSSED BY CE OFFICERS WITH THE SSCI, WHO HAVE EXPRESSED THEIR CONCERN TO THE DEPARTMENT. THE FACT, OF COURSE, IS THAT STATE DEPARTMENT DOES NOT HAVE SUFFICIENT FUNDS TO HAVE MARINE GUARDS AT ALL LOCK AND LEAVE EMBASSIES AND NWBOLTON APPRECIATES THAT. (FYI: THIS IS A PARTICULARLY CONTENTIOUS ISSUE WITH THE AMBASSADOR. WE SEE NO POINT IN ALIENATING HIM BY PUTTING
