ATTENTION ASST. DIRECTOR COURTNEY EVANS. SAMUEL M. GIANCANA,
AKA. AR. DAILY SUMMARY. CG 6486-C* ADVISED LAST NIGHT OF
LENGTHY CONFERENCES BETWEEN GIANCANA AND VARIOUS HOODLUMS.
AMONG THOSE ATTENDING AS BEING IDENTIFIED WERE DOMINIC BLASI
AND ROSS PRIO. PRIO WAS CONCERNED OVER THE FACT THAT ATTORNEY
GENERAL KENNEDY IS MAKING AN APPEARANCE IN CHICAGO BEFORE AN
ITALIAN AMERICAN GROUP DURING COLUMBUS DAY PROCEEDINGS HERE.
HE FELT THAT ONE ANUNZIO, HEAD OF THIS GROUP, SHOULD BE TOLD
TO TONE DOWN ON KENNEDY, THAT THIS WAS AN OBVIOUS ATTEMPT,
ACCORDING TO PRIO, OF KENNEDY TO CONVINCE THE ITALIAN PEOPLE
HERE THAT HE IS FRIENDLY TO THIS ETHNIC GROUP. PRIO ADVISED
GIANCANA THAT HE IS CONNECTED WITH AN OFFICIAL OF A NEW MAGAZINE
IN CHICAGO BELIEVED TO BE NAMED SHOW BUSINESS ILLUSTRATED,
AND THAT THIS OFFICIAL IS WILLING TO EDITORIALIZE THE MAGAZINE
AGAINST ALL LAW ENFORCEMENT OFFICIALS CREATING INVESTIGATIONS
AGAINST THE HOODLUM ELEMENT. ONE SUGGESTION OFFERED BY GIANCANA
WAS TO HAVE THIS INDIVIDUAL COMMENT ON THE FACT THAT KENNEDY IS
SPENDING ALL HIS TIME INVESTIGATING BOOKMAKERS AND NOT PAYING
ATTENTION TO THOSE WHO ARE ATTEMPTING TO OVERTHROW THE GOVERN-
MENT, NAMELY, THE COMMUNISTS. TWO UNKNOWN PERSONS SPOKE WITH
GIANCANA AND ADVISED THAT THEY HAD IDENTIFIED TWO INFORMANTS

 UTILIZED BY THE STATES ATTORNEYS OFFICE, COOK COUNTY, IN MAKING GAMBLING RAIDS. AFTER OUTLINING TO GIANCANA THE REASONS FOR SUSPECTING ONE INFORMANT, GIANCANA GAVE INSTRUCTIONS TO "PUT HIM IN A STEAM BOX, TAKE HIM FOR A RIDE, HIT HIM IN THE HEAD AND THROW HIM IN THE (UNKNOWN)." POSSIBILITY EXISTS THIS INFORMANT MAY BE IDENTICAL TO CG 6093-C. THIS INFORMANT POSSIBLY HAS BEEN FURNISHING INFORMATION DIRECTLY TO THE STATES ATTORNEYS OFFICE RELATING TO GAMBLING ACTIVITIES. IT IS NOTED THAT THE INFORMANT HAS BEEN IN CONTACT WITH THE STATES ATTORNEYS POLICE CONCERNING HIS RECENT CONVICTION IN COOK COUNTY FOR INTIMIDATION OF A WITNESS. THE INFORMANT POSSIBLY WAS CONTACTED BY THE STATES ATTORNEYS POLICE AND VOLUNTEERED TO ASSIST THE STATES ATTORNEYS OFFICE IN RETURN FOR CONSIDERATION OF THE THEN PENDING CASE IN COURT. IN ORDER TO PROTECT SOURCE IT IS NOT DEEMED ADVISABLE TO DISCUSS THESE POSSIBILITIES WITH INFORMANT. CG 6093-C BEING ALERTED BY CONTACTING AGENT TO BE EXTREMELY CAUTIOUS AND ALERT IN ALL HIS FUTURE ACTIVITIES. THIS ALERT WILL BE GIVEN HIM IN SUCH A WAY SO THAT THE SOURCE IS COMPLETELY PROTECTED. CHICAGO CONSIDERS IT INADVISABLE TO FURNISH INFORMATION CONCERNING OTHER INFORMANT TO STATES ATTORNEYS OFFICE IN VIEW OF THE FACT THAT CG 6486-C* ADVISED LAST NIGHT THAT THEY HAD SOMEONE IN THE STATES ATTORNEYS OFFICE ON THEIR PAYROLL AND THAT HE WAS FURNISHING THEM INFORMATION CONCERNING ACTIVITIES IN STATES ATTORNEYS OFFICE. ROSS SPENCER, FORMER AGENT AND CHIEF INVESTIGATOR AT STATES ATTORNEYS OFFICE, IS PRESENTLY OUT OF THE COUNTRY ATTENDING IACP CONVENTION. EVEN IF INFORMATION EVENTUALLY GIVEN TO SPENCER, THIS OFFICE HAS NO CONTROL OVER THE DISSEMINATION WHICH SPENCER MIGHT
