The RCMP Toronto report identifies Ben Littman of 287 Spondina Street, Toronto, Ontario, as Benjamin Leitman; and Ernie Shimanky, owner of the Isabelle Hotel in Toronto, as Ernest Chamandy, and further notes that while neither of the two have come to the attention of the RCMP in connection with illicit drug traffic, Leitman could always be considered a suspect, but there has been no reason to suspect Chamandy.
