ON SIMILAR CHECKS NOTATION SHOWED THE ENTERPRISE AS QUOTE R AND R ENTERPRISES UNQUOTE. EFFORTS WILL BE MADE TO RESOLVE THIS DISCREPANCY. EMANUEL ROTHMAN IS ROSSELLI-S AUDITOR.

ON SEPTEMBER TWENTY NINE LAST AND OCTOBER TWO LAST, ROSSELLI ISSUED CHECKS OF TWO HUNDRED SEVENTY FIVE DOLLARS EACH PAYABLE TO DIPLOMAT APARTMENTS, LAS VEGAS. FORMER CHECK HAS NOTATION ON FACE QUOTE SEPT RENT UNQUOTE. PRIOR TO THIS, ROSSELLI -S RENT AT DIPLOMAT APARTMENTS HAS BEEN TWO HUNDRED DOLLARS PER MONTH. LAS VEGAS DETERMINE IF ROSSELLI HAS CHANGED APARTMENTS AT DIPLOMAT APARTMENTS.
