LA FOUR TWO SIX EIGHT C OBSERVED ROSSELLI AT FRIAR-S CLUB, BEVERLY HILLS, CALIF., ABOUT FOUR P. M. OCTOBER THIRTY LAST IN COMPANY IRVING J. LEFF, A PART OWNER, NEW FRONTIER HOTEL, LAS VEGAS, AND AN INDIVIDUAL CALLED QUOTE ROSS UNQUOTE. LEFF RELATED THAT DURING CUBAN CRISIS LAST WEEK PEOPLE RUSHED TO BUY FIREARMS AND AMMUNITION AND ROSSELLI SAID THAT HE WAS IN MIAMI DURING THIS PERIOD AND PEOPLE THERE WERE DOING THE SAME THING.

LEFF ASKED ROSSELLI WHY HE DIDN-T CALL AND TELL LEFF WHAT TO DO. ROSSELLI SAID HE WAS IN LAS VEGAS AND LEFF COULD HAVE CALLED HIM BUT LEFF WAS QUOTE TOO CHEAP UNQUOTE TO MAKE THE CALL. INFORMANT SAID THAT APPARENTLY ROSSELLI RETURNED TO LOS ANGELES FRIDAY, OCTOBER TWENTY SIX LAST AND THEN THE SAME NIGHT OR THE FOLLOWING MORNING DEPARTED NOV 2 1962
