LA FOUR TWO SIX EIGHT DASH C ADVISED ROSSELLI AT THE FRIAR-S CLUB AFTERNOON NOVEMBER ONE LAST. DURING AFTERNOON NAME OF PAT O-MALLEY, WHO IS ALLEGEDLY AFFILIATED WITH VENDING MACHINE OPERATIONS IN CHICAGO AREA, WAS MENTIONED AND ROSSELLI STATED THAT HE KNEW EVERYONE IN THE RACKETS IN CHICAGO BUT THAT HE NEVER HEARD OF O-MALLEY. ROSSELLI ALSO SAID THAT IN LAS VEGAS QUOTED ODDS ARE EIGHT TO FIVE THAT PAT BROWN WILL WIN OVER NIXON IN THE RACE FOR GOVERNOR OF CALIFORNIA. ROSSELLI THEN ADDED THAT HE WAS BETTING ON BROWN TO WIN BUT HE WAS GOING TO VOTE FOR NIXON. IN THIS REGARD IT IS NOTED THAT ROSSELLI IS NOT A REGISTERED VOTER IN LOS ANGELES COUNTY AND BECAUSE OF HIS CONVICTION IN FORTY THREE IS NOT ENTITLED TO VOTE.
