JOHN ROSELLI, AKA, AR. LA FOUR TWO SIX EIGHT DASH C ADVISED HE OBSERVED ROSELLI AT FRIAR-S CLUB, B. H., CALIFORNIA ABOUT FOUR P. M., NOVEMBER SEVEN LAST. ROSELLI TALKING WITH IRVING J. LEFF, PART OWNER, NEW FRONTIER HOTEL, LAS VEGAS. ROSELLI STILL AT CLUB AT SIX THIRTY P. M. WHEN INFORMANT LEFT. NEIGHBORHOOD SOURCE ADVISED THAT NINETEEN SIXTY TWO FORD T-BIRD, CALIFORNIA LICENSE XBU EIGHT FOUR TWO PARKED IN ROSELLI-S APARTMENT GARAGE STALL MORNING NOVEMBER EIGHT INSTANT. BUREAU PREVIOUSLY ADVISED THIS CAR REGISTERED TO HERMAN SPITZEL, FORMER EMPLOYER AND CLOSE FRIEND OF ROSELLI. IN MARCH, NINETEEN SIXTY ONE, ROSELLI CONTACTED PRIVATE DETECTIVE FRED OTASH REGARDING AN INVESTIGATION OTASH WAS CONDUCTING FOR PETER FAIRCHILD, GUARDIAN OF ROBERT MACHRIS

WESTBROOK, TWENTY ONE YEAR OLD OIL HEIR, WHO MARRIED ONE JUDI MEREDITH. WESTBROOK FILED SUIT FOR DIVORCE AND MEREDITH DEMANDED TWO HUNDRED AND FIFTY THOUSAND DOLLAR SETTLEMENT. INVESTIGATION BY OTASH ALLEGEDLY INDICATED MEREDITH NOTHING MORE THAN QUOTE HIGH CLASS PROSTITUTE UNQUOTE AND REPORTEDLY HAD BEEN INTIMATE WITH SEVERAL CELEBRITIES IN LAS VEGAS. ROSSELLI TOLD OTASH HE WAS SPEAKING IN BEHALF OF CELEBRITIES WHO MIGHT HAVE POSSIBLE BEEN INVOLVED WITH MEREDITH AND REPORTEDLY OFFERED OTASH FIFTEEN THOUSAND DOLLARS IF HE WOULD TAKE NECESSARY STEPS TO AVOID ANY BIG SCANDAL OR DEROGATORY PUBLICITY. WESTBROOK GRANTED ANNULMENT AND ALLEGEDLY MADE QUOTE UNDER THE TABLE SETTLEMENT UNQUOTE WITH MEREDITH OF THIRTY FIVE THOUSAND DOLLARS. IRS AGENTS ADVISED
