LA FOUR TWO SIX EIGHT C ADVISED HE OBSERVED ROSSELLI AT FRIAR-S CLUB, BEVERLY HILLS, EVENING NOVEMBER NINE LAST AND LATE AFTERNOON AND EARLY EVENING NOVEMBER TWELVE LAST. NEIGHBORHOOD SOURCE LEARNED ROSSELLI AT LOS ANGELES APARTMENT MORNING NOVEMBER THIRTEEN INSTANT.

ACCORDING TO LA FOUR TWO SIX EIGHT C, ON NOVEMBER TWELVE LAST, ROSSELLI AT FRIAR-S CLUB WITH QUOTE COMMANDER UNQUOTE HERMAN SPITZEL, CLOSE FRIEND AND FORMER EMPLOYER OF ROSSELLI. ROSSELLI REMARKED QUOTE THE DIRTY SOB-S ARE DIGGING INTO TWO OF MY CORPORATIONS BUT THEY ARE NOT GOING TO FIND ANYTHING BECAUSE I HAVE A GUY WORKING FOR ME THAT HAS IT SO SCREWED UP THEY WILL NEVER FIND ANYTHING UNQUOTE.
