

In accordance with instructions concerning the handling of **double agents**, there are attached hereto the original and 9 copies of a letterhead memorandum. The letterhead memorandum has been classified "SECRET," in order to protect the **identity of a double agent** of continuing value to the U.S. *(S)*

(S) As set forth in referenced letter, **DOLPHIN's principal** requested him to furnish information on a monthly basis concerning anti-CASTRO activities in the U.S. *(S)*

In view of this, the Miami Office will have **the informant prepare** and the Miami Office will forward a letter containing the information set out in the attached letterhead memorandum. This information will be prepared **in secret writing.** *(S)*

The Bureau is requested to advise whether or not **DOLPHIN** will be **authorized** to make the information available to **his Cuban principal** on April 7, 1967. *(S)*
