"My dear IRVING:

His Excellency has received your cable.

You have left His Excellency's office with the impression  
(B val that he) was willing to offer the new Ambassador the  
most loyal and frank collaboration.

However, a certain stiffening has characterized the first  
contact between TIMMONS and Foreign Minister CHALMERS and  
Deputy Foreign Minister RAYMOND at the Foreign Ministry  
Building.

The Foreign Ministry's general opinion is that he is the  
least qualified at the present time and that his presence could  
be fatal for the resumption of relations.

Please see if he can be recalled before he presents his  
credentials.

(B val Anticipating) the Ambassador's arrival, NORMAN WARREN, JOHN HACEY and (B val company) have redoubled their ardor against the President.

I believe that it is preferable to make these transfers without the opinion of any unfriendly person. This action is always considered unfriendly.

President DUVALIER has asked for these recalls to permit Ambassador TIMMONS to be the [1 gr G] of a Haitian-United States rapprochement. Therefore, as we say, the departure of JOHN HACEY (B val and company) is imperative.

We are expecting your immediate reply.

You have seen, My dear IRVING, that the recall of WARREN, WARNER, HASSEY, MOSS and TIMMONS must be obtained.

JACQUES FOURCAND."
