In 1954 a procedure was approved whereby we could attribute certain information received from CIA under the symbol "Bureau Informant 100." CIA forwards this information utilizing an SP (Special Projects) number. They are asking our concurrence in a method of addressing and forwarding this material. They also suggested forwarding [SCOPE] material (s) (sensitive information concerning Israeli intelligence activities) in the same manner. They proposed to forward this material by courier in sealed envelopes to be delivered to Liaison Section Supervisor D. J. Brennan, Jr. It is felt this is the best way in which this highly sensitive material can be handled. (X)
