1. Reference is made to Subject on whom considerable information has been disseminated to the Bureau, the last from this Agency being CSCI-316/03970-68 dated 9 October 1968.

2. Attached herewith is a copy of the 9 September 1968 debriefing of Libertad ANTIGUA Arrencibia which was provided by our Miami representative.

3. Information on the following individuals was compiled from the files of this office and from the files of a group of Cuban emigres trained in the techniques of information collection:

EX-100

a. Manuel ABELEND Martin was born in Havana, Cuba on 17 April 1911. He is married to Elena RODRIGUEZ Regulez, a Cuban citizen. His parents were Juan ABELEND, a former Cuban Consul in Lisbon, Portugal, and Concepcion MARTIN. Both parents are deceased. Manuel's brother, Gonzalo ABELEND Martin, is employed at the Brazilian Consulate in Miami, Florida. Manuel was contracted to work for the Brazilian Embassy in Havana, Cuba from 1 January 1933 through the first part of 1963. He served as Vice Consul up until his departure from Cuba in 1963. His wife was also employed in the same Embassy. Since 1963, ABELEND has been in Paris, France reportedly serving as Consul in the Brazilian Embassy. According to a reliable source, he has traveled widely throughout Europe and Latin America. He is well educated, skillful and has a great deal of experience in clandestine
