

By airmail, we are sending you information regarding manifestations of the sorrow of the Government of Mexico because of the assassination of President KENNEDY, consisting of messages to President LYNDON B. JOHNSON, Secretary RUSK and Mrs. KENNEDY, as well as a decree declaring a three-day period of official mourning.

The Foreign Minister will attend, as the personal representative of our Chief Executive, the funeral ceremonies which will be held this coming Monday in Washington.
