In conversation with me, MCCLOY, a member of the presidential  
commission stated that he has serious doubts of the credibility  
of the investigation to date. He does not eliminate the possibility  
that the attempt on KENNEDY was made by two persons. However, in  
view of JOHNSON's order that the commission investigate also the  
circumstances of OSWALD's slaying, some of the commission's  
operations and its report could come after RUBY's trial and perhaps  
even after the verdict and appeals. In the meantime the trial  
was postponed until 3 January [sic], and the FBI released to the  
press information that their investigation confirms OSWALD's guilt,  
and that he had no accomplices.
