Reference your cables 12^a and 13^a.

I have the honor to inform you that during an audience on 23 December 1963, the Philippine Ambassador offered His Royal Highness the good offices of President MACAPAGAL to resolve the Cambodian-American differences. Out of Cambodia's friendship for the Philippines, His Royal Highness accepted the good offices offered, but not mediation, as was reported in the Philippine radio and press.

Conditions: 1) Ambassador YOST, who termed an alleged declaration from the Information Ministry barbarous, withdraw this expression

2) Ambassador ~~SPROUSE~~ must stop his investigation to find out whether the Royal Government and the ~~Kmer~~ people rejoiced over the death of President KENNEDY.

Therefore, no American-Cambodian negotiations are under Philippine mediation.
