The Chairman. The hearing will come to order.

I would like to ask Mr. Schwarz if he would give us a brief synopsis of what we intend to question our witness about this morning.

Mr. Schwarz. The witness this morning will only be a single witness. He is Mr. Samuel Halpern. He was in the Far East, and I have now found out he was involved in the Sukarno moving and some alleged killing of an agent in Thailand, which are collateral matters that we may want to take up with him at the end.

But he came back here in the fall of 1961 and was instructed as assistant to get into the Cuban matter. And he will testify that he was told that they would proceed to overthrow the Castro government, and that there were no holds barred.

He will then describe the way in which they worked with the Special Group.

The Chairman. What was Halpern's position?

Mr. Schwarz. Halpern's position was as Executive Assistant to Harvey. And Harvey, you will remember, was the man that was actually in charge of the Cuban position.

The Chairman. When are we going to get Harvey?

Mr. Schwarz. He is coming next Wednesday morning.

We are going to get some of this same conflict between the no-holds-barred testimony, which in his mind I guess he

3 Mr. Halpern. A Mr. Ghose Zogbey. He was my branch
4 chief.

5 Mr. Schwarz. Is he alive today, or is he dead?

6 Mr. Halpern. He died last year.

7 Mr. Schwarz. Approximately when in the fall of 1961
8 did that meeting take place?

9 Mr. Halpern. About the middle of October 1961.

10 Mr. Schwarz. What instructions were you given by Mr.
11 Bissell at tht meeting?

12 Mr. Halpern. Mr. Bissell said he had recently -- and
13 he didn't specificy the date or the time -- he had recently
14 been chewed out in the Cabinet Room of the White House by
15 borh the President and the Attorney General for, as he put
16 it, sitting on his ass and not doing anything about getting
17 rid of Castro and the Castro regime. His orders to both
18 Mr. Zogbey and to me were to plan for an operation to
19 accomplish that end.

20 Mr. Schwarz. Was any content put into the term
21 "get rid of", or was that the term that was used, and only
22 that term?

23 Mr. Halpern. To the best of my recollection, that was
24 it. There was no limitation of any kind. Nothing was for-
25 bidden, and nothing was withheld. And the objective was to

2 Mr. Schwarz. And did you talk about tactics at all
3 in that meeting, or was it just a general discussion about
4 getting organized.

5 Mr. Halpern. Just a general discussion as to what we would
6 do, how we would proceed, and what we would need. And at
7 that point I had no idea how many people were left on the staff
8 in the branch only having been on the job a day or a day and
9 a half.

10 Mr. Schwarz. Shortly after that time did you get put in
11 contact with a general?

12 Mr. Halpern. Yes, sir. General Lansdale.

13 Mr. Schwarz. And what was his function when you were
14 introduced to him?

15 Mr. Halpern. Both Mr. Zogbey and I were introduced
16 to him as the new chief of Operations for a government-wide
17 effort to accomplish the removal of Castro and the Castro
18 regime. This effort was to include not only CIA but the
19 Department of State and the Department of Defense. And
20 General Lansdale was to be the Chief of Operations for that
21 outfit.

22 Mr. Schwarz. And did you brief him about Cuba or did
23 he brief you about the operation, or what was the nature of that?

24 Mr. Halpern. No, we briefed him first in the old
25 Situation Room, what used to called the Ibell Building, which

1 Mr. Halpern. It wasn't a matter of General Lansdale's
2 being in charge, or the Attorney General being in charge,
3 nobody objected to General Lansdale reporting to the Attorney
4 General.

5 It was a matter of whether this would be done through
6 the normal chain of command, or whether we would actually be
7 under the General's direct command.

8 Mr. Schwarz. But it still is a characterization, you
9 were dealing with organization and bureaucracy?

10 Mr. Halpern. That is right. And drafting papers.

11 Mr. Schwarz. Drafting papers to do what?

12 Mr. Halpern. To try to get organized in terms of how
13 we would accomplish the objective.

14 Mr. Schwarz. Did any of those papers that you drafted
15 in those early stages include any reference to assassination
16 as a device to accomplish the objective?

17 Mr. Halpern. No, sir.

18 Mr. Schwarz. Now, did Mr. Helms enter the picture in
19 the latter part of December 1961?

20 Mr. Halpern. That is correct.

21 Mr. Schwarz. Describe how he came into the picture.

22 Mr. Halpern. To my knowledge, Mr. Zogbey described to
23 me a meeting he had been at at the Director's morning staff
24 meeting -- this is Mr. McCone's morning staff meeting -- in
25 which Mr. McCone, almost in terms of a bombshell for the

1 group at the meeting, stated that Mr. Helms would henceforth
2 be -- the words were, his man on Cuba. This was something
3 that nobody in the room apparently had any inkling of, and
4 particularly Mr. Helms, nor ~~Mr. Zogbey~~.

5 The Chairman. May I ask you to repeat that?

6 I am sorry, I just didn't catch it.

7 Mr. Halpern. At a meeting sometime in December 1961,
8 which was the morning staff meeting that the Director held, and
9 ~~Mr. Zogbey~~ was present --

10 Mr. Schwarz. But you were not?

11 Mr. Halpern I was not, I got this from ~~Mr. Zogby~~ --
12 the Director, Mr. McCone, announced that Mr. Helms would be
13 his man on Cuba, Mr. Helms would then be the Chief of Operations
14 for the Deputy Director of Plans, and Mr. Bissell was in the
15 room as the DDP.

16 Mr. Helms had no inkling of this before the meeting,
17 and so stated to ~~Mr. Zogbey~~, and even asked ~~Mr. Zogby~~ if he had
18 had any inkling before the meeting.

19 ~~Mr. Zogbey~~ told me that he had none whatsoever.

20 Mr. Schwarz. Did Mr. Helms then come and visit your
21 new organization and tell you to make some changes?

22 Mr. Halpern. Yes. He came to ~~Mr. Zogbey~~'s office and looked
23 at the list of officers, male and female, who were still
24 working in the branch. Most of them were the remnants of the
25 people from the old Bay of Pigs operation who had not yet been
reassigned.

1 involved in this operation? That was the first reference I

3 Mr. Schwarz. There was no such previous evidence.

4 Mr. Halpern. We had a number of female officers, and
5 still do, in our branches. And there were some in the Cuban
6 branch and the Cuban task force.

7 Senator Huddleston. What types of activities did they
8 participate in?

9 Mr. Halpern. Oh, recruiting of agents, the handling
10 of agents, disseminating reports, preparing propaganda guid-
11 ances, preparing papers for a special group as appropriate,
12 doing the work of any other officer.

13 Senator Huddleston. Can you name one or suggest one
14 that was heavily involved in the assassination attempt?

15 Mr. Halpern. Oh, I don't know of any in the assassina-
16 tion attempt per se.

17 Senator Huddleston. You don't know of any?

18 Mr. Halpern. No, sir.

19 Senator Huddleston. Thank you.

20 The Chairman. Senator Mondale?

21 Senator Mondale. I am sorry I came in late, Mr. Hal-
22 pern, and missed some of your testimony. As I came in you
23 were saying that orders came from somewhere to get off your
24 ass.

25 Mr. Halpern. Yes, sir. Mr. Bissell told Mr. Zogbey

1 cers whose objective would be to plan for the overthrow of
2 the Castro regime.

3 Mr. Smothers. Was it your understanding that these
4 plans were to extend to assassination?

5 Mr. Halpern. That word was not used, sir. But no
6 holds were barred, and we had no limitation.

7 Mr. Smothers. Let me ask you it another way. What was
8 your understanding of what Mr. Bissell had been told to do
9 by the President and the Attorney General?

10 Mr. Halpern. To get rid of Castro and the Castro regime
11 on the Island of Cuba.

12 Mr. Smothers. Did Mr. Bissell convey to you the idea
13 that that included killing Castro?

14 Mr. Halpern. The subject never came up per se.

15 Mr. Smothers. What did you come away from that meeting
16 expecting to do?

17 Mr. Halpern. We were very hard put to come up with
18 any real ideas. We didn't know what to do, frankly. And we
19 went back -- one thing we both agreed on, both Zogbey and
20 I, is that we were not going to come up with a piece of
21 paper which said this was going to be easy or could be done
22 overnight, or could be done with mirrors.

23 The Chairman. Did you come away after your conversation
24 with Mr. Bissell with the idea that he had instructed you
25 to come up with a plan of some kind designed to overthrow,

2 The Chairman. I would like to take this and several
3 other questions up with the committee, one of which deals
4 with the question of the August recess. And I want to
5 confer with you on that, too.

6 How many more questions do you have?

7 Mr. Schwarz. Instead of asking the other questions I will
8 ask whether he knows anything about them, and we could bring
9 him back later if he does.

10 Do you know anything about the film made in order
11 to discredit Mr. Sukarno by showing immoral activity on his
12 part?

13 Mr. Halpern. Yes, sir.

14 Mr. Schwarz. We will bring you back on that.

15 The Chairman. Can we get that done now?

16 Mr. Schwarz. Such a film was made in Hollywood, was it?

17 Mr. Halpern. I don't know where it was made, sir,
18 but I know it was made.

19 Mr. Schwarz. It was made in the U.S.?

20 Mr. Halpern. As far as I know it was.

21 Mr. Schwarz. And was that done under your direction?

22 Mr. Halpern. Well, it was done at the Far East Division
23 request, and I was the one who did the negotiating with the
24 Office of Security.

6 Mr. Schwarz. What was the plan?

7 Mr. Halpern. The plan was to have ~~such a film from~~
8 ~~which we could make a film~~ which we could use in the propaganda
9 activity ~~against Sukarno in terms of him being close to the~~
10 ~~Russians, because the woman was supposed to be the Russian~~
11 ~~blonde woman that was assigned to Mr. Sukarno as escort~~
12 ~~officer when he visited the Soviet Union, and then went back~~
13 ~~and stayed with him for some time in Indonesia.~~

14 Mr. Schwarz. In short, it was a ~~fake movie~~ which was
15 designed to put ~~Mr. Sukarno~~ in an undesirable light, ~~by~~
16 ~~showing that he was having relations with some Russian~~
17 ~~female?~~

18 Mr. Halpern. And, therefore, ~~in Russian control.~~

19 Senator Mondale. How was ~~that film~~ supposed to get to
20 ~~Indonesia?~~

21 Mr. Halpern. It wasn't a ~~film~~. The original plan was
22 to use ~~clips from~~ it in propaganda leaflets, and pamphlets,
23 and things like that, just ~~pictures from the film.~~

24 Mr. Schwarz. Who authorized that?

25 Mr. Halpern. ~~Mr. Ulmer~~, who was then Division Chief.

such a person, in which you participated along with a man called Dennis Fleming and one called Peter Joast?

Mr. Halpern. That I participated? No, sir.

Mr. Schwarz. Do you know anything about the killing of a CIA operative in Bangkok?

Mr. Halpern. No, sir. I was only in Bangkok, I think, once in my life.

Mr. Schwarz. That doesn't ring a bell at all?

Mr. Halpern. No, sir.

Mr. Schwarz. Do you know about any other killings?

Mr. Halpern. No, sir.

The Chairman. Any other questions?

Senator Schweiker. I just want to say, Mr. Chairman, that I would like to compliment the witness for some very clear and impartial answers, instead of the partial amnesia that we have run into lately.

And I think your kind of candor is very helpful to us in this committee to do the job. And I think it was very refreshing to hear some clear-cut specific recommendations of what did or did not happen. I just want to thank you.

The Chairman. I agree.

If there are no further questions, I think that completes the interrogation.
