Helms pointed out, however, that the objective of Operation MONGOOSE would have to be determined at some point since the Cubans with whom we have to work were seeking a reason for risking their lives in these operations. Helms detailed his conversation with the young Cuban from the ~~ADRE~~ (2) who pointed out that they were willing to commit people only on operations which they regarded as sensible. Helms defines sensible in Cuban terminology as meaning an action which would contribute to the liberation of their country, another way of saying that the United States, perhaps in conjunction with other Latin American countries, would bail them out militarily. Helms' point was specially echoed by Huston and Ryan.
