2 prietary firm, like Air America or **Palway**, Incorporated or the  
3 Mullen Company would contact, you deal with contact men, some  
4 of whom were military who are cleared, but others are agency  
5 who are in there.

6 Like Gil Greenaway was in the Pentagon, he was an  
7 Agency employee, he was not a military man. So when air lines  
8 contacted Greenaway they thought they were contacting a military  
9 man, but he was really an employee of the Agency, for other
