3 MR. MARCHETTI: You mean found to be illegitimate
4 defectors?

5 MR. OLSEN: No, found to be legitimate defectors --
6 well, either way.

8 time. Usually I didn't have any direct dealings. They were
9 handled by the Clandestine Services. But you would know the

1 defecotrs which you believe to be questionable as to whether

5 You remember the **Winey-Rouse** case?

6 MR. OLSEN: Yes. You mentioned that in your book, I

9 happened, but I knew practically nothing about it in the Agency.
10 For one reason, I didn't pay any attention to it. I had no

12 This happened to be a case where **Rouse**, under Agency
13 orders, was directed to **Winey** as being a Soviet agent **in the**
14 **Estonian group**. And **Winey** apparently to this day claims
15 absolute innocence, and said that he was framed, and it was
16 done for other reasons, because he didn't see eye to eye with the
17 Agency.

18 MR. OLSEN: You don't know the story behind that, I
19 take it?

20 MR. MARCHETTI: No. But you could find out. I don't
21 know what the Agency was doing. All I know is that Helms
22 submitted some sort of affidavit which the judge accepted, and
23 on the basis of that the case was resolved in favor of **Rouse**.
24 He had to identify **Rouse** as being in the Agency's employ and

3 MR. ROETHE: There is one reference to breaking into
4 embassies at page 199. And there is no reference to any
5 particular embassy. Are you aware of any activity where the
6 CIA was actually implicated in breaking into an embassy? You
7 have already talked about the Cilean Embassy.

8 MR. MARCHETTI: This was based on information that was
9 available in the Houston Plan, which by that time had become
10 public. And also certain background information about ~~the~~
11 ~~capabilities of the NSA in its technical field~~, and certain CIA
12 clandestine abilities. And it was all rolled into one as a
13 supposition.
