THE FOLLOWING ARE REMARKS MADE BY OFFICIALS OF THE CUBAN EMBASSY IN SANTIAGO REGARDING THE ASSASSINATION OF PRESIDENT KENNEDY:

ON 22 NOVEMBER JOSE TOHA, VICE PRESIDENT OF THE CHILEAN CUBAN CULTURAL INSTITUTE AND DIRECTOR OF THE PRO-CASTRO LEFT IST PRESS ULT IMA HORA , INFORMED PEDRO MARTINEZ PIREZ, CHARGE OF THE CUBAN EMBASSY IN SANTIAGO, THAT KENNEDY HAD BEEN ASSASS INATED. TOHA SAID "ESTE ASUNTO DE KENNEDY SE ESTA PONIENDO COLOR DE (POSSIBLY MEANS ASSASSINATION OF KENNEDY LOOKS LIKE IT COULD HAVE SERIOUS REPERCUSSIONS). MARTINEZ COMMENTED THAT HE HEARD THAT THE PERSON ARRESTED WAS PRESIDENT OF A FAIR PLAY FOR CUBA COMMITTEE AND THAT IF THE YANKEES OR CIA ASSASSINATED KENNEDY TO RESUME THE ASSAULT ON CUBA, THEN A THIRD WORLD WAR

WOULD START. HE SAID THINGS ARE VERY CLEAR AND THERE IS NO DOUBT THAT THEY HAVE ASSASSINATED HIM, THE CONTRADICTIONS ARE WELL DEFINED AND THE MOMENT WAS VERY SPECIAL, LIKE THAT OF THE MAINE. MARTINEZ SAID THE UNITED STATES IS NOW IN THE MOST DIFFICULT POSITION OF THE PAST SEVERAL YEARS IN LATIN AMERICA, THE WORLD, GOULART, ARGENTINE PETROLEUM, PERUVIAN LANDS, CHILEAN MINES AND IN GENERAL ALL OVER LATIN AMERICA. TOHA SAID HE WAS VERY WORRIED AFTER READING THE CABLE TRAFFIC. MARTINEZ ADDED THAT IF THE USA IS THINKING OF INVADING CUBA THEN THEY MUST HAVE EVERYTHING ALL PREPARED AND ALL THE STRATEGY READY AND THEREFORE THE ALARM MUST BE GIVEN SO THAT CUBA CAN BE PREPARED.

- B. THE CUBAN CONSUL AT VALPARAISO CALLED THE CUBAN EMBASSY IN SANTIAGO TO DETERMINE POLICY IN THE MATTER OF FLYING THE FLAG AT HALF MAST. THE REPLY WAS THAT THERE ARE NO DIPLOMATIC RELATIONS WITH THE USA AND THAT NO OFFICIAL WORD HAD YET BEEN RECEIVED FROM CUBA, SO THEREFORE NOTHING SHOULD BE DONE. (FIELD COMMENT: THIS IS AGAINST PROTOCOL BECAUSE THE CHILEAN GOVERNMENT HAS DECREED OFFICIAL MOURNING INCLUDING FLYING FLAGS AT HALF MAST.)
- C. MARTINEZ REFUSED TO MAKE FURTHER STATEMENTS PREFERRING TO WAIT FOR OFFICIAL WORD FROM HABANA. SEVERAL TIMES HE DENIED THAT THE ASSASSIN WAS INVOLVED IN THE FAIR PLAY FOR CUBA COMMITTEE INSISTING THAT THIS PERSON IS ONLY A SUSPECT AND THAT EXTREME RIGHTISTS OR SEGREGATIONISTS ARE TO BLAME. MARTINEZ SAID HE BELIEVED THAT THE UNITED STATES GOVERNMENT WOULD TRY TO PUT THE BLAME ON CUBA.
