

Dear Mr. Sprague:

I was so intrigued by your selection as Chief Counsel and Staff Director of the Select Committee on Assassinations that I had to write to you. I am an extremely bright and capable graduate of Columbia Law School (May 1976) who happens to be one of your cousin Ziporah Mordana's daughters, and one of Debora Horowitz's granddaughters.

I hope you will forgive me for thus invoking kinship, but I am so eager to work with you that I am tempted to use any and all reasonable means to help achieve that objective. "Uncle" Louis heartily agreed that I should acquaint you with my existence, and gave me your address.

My educational background includes being a Stone Scholar and "VG" student at Columbia Law School, and a Phi Beta Kappa at Barnard College (undergraduate division of Columbia University). While in law school, I persuaded the Columbia Graduate School of Journalism to admit me to some of its professional workshops (in reporting, writing, editing, etc.), and completed half the Master's Program in Journalism.

My professional legal experience has involved a great deal of litigation practice, from doing research and discovery, to writing complaints, interrogatories, pre-trial memoranda and appellate briefs, in areas ranging from anti-trust to customs seizures.

My most challenging employment has been with the American Civil Liberties Union, where I have been working since the Summer of 1975. In my capacity as law clerk to the Legal Director, I was given the responsibility for handling the pre-trial


