Interview: (Synopsis)

Charles Steele passed out Pro-Cuba leaflets with LHO. Subject refused to answer questions concerning his knowledge of LHO prior to passing out leaflets on Canal St. He states he was inside of unemployment office on Canal Street when he was approached by LHO and was offered \$5.00 to pass out leaflets. He accepted the offer and after passing out the first batch, read the leaflets, stopped, collected his money and left. The subject said he didn't know the second male who was assisting,-- describes him as, white male, 20, light brown hair, medium height and build, and brown eyes. The subject refuses to answer when asked if he saw LHO again.

Subject states he was not a member of any organization during this period. He identified photos #5, Clay Shaw and #57, LHO. The photo book supplied by the committee is numbered in sequential order from 1-110 with #72/73 missing.

Subject requests copy of his Warren Commission testimony.
