(LOCAL AGENCY-SUBJECT) On 7 December 1966, files of the San Francisco Office, Federal Bureau of Investigation (FBI), 450 Golden Gate Avenue, San Francisco, California, were examined regarding SUBJECT by a representative of Source who furnished the following:
