(DEVELOPED EMPLOYMENT) On 15 October 1958, the payroll files of the Repeat-O-Type Stencil Manufacturing Company, 153 Coffey Street, Brooklyn, New York, were examined with the assistance of Harry Hofner, Certified Public Accountant, and revealed the following information in substance:
