4. REPORT OF FINDINGS

(EDUCATION INTERVIEW) On 27 September 1968, Mrs. Mildred Kraft, assistant registrar, Bronx Community College (BCC), 120 East 184th Street, Bronx, New York, was interviewed in an attempt to locate former instructors of MARTI, who attended BCC during the Summer session of 1967, with results as follows:

Kraft stated that MARTI'S records were incomplete, and that there was no indication as to who HIS instructors might have been. There was no major course of study. Source could suggest no one who might have knowledge of SUBJECT.
