## 4. REPORT OF FINDINGS

(LISTED EMPLOYMENT SUPERVISOR) On 14 October 1968, Bob Wang, Warehouse Manager, Polly Perry Stores, 33-37 East 17th Street, New York, New York 10003, who resides at 3028 West 29th Street, Brooklyn, New York 11224, was interviewed at his place of employment concerning Manuel MARTI. Source who was SUBJECT'S immediate supervisor from September 1964 to February 1965 stated substantially as follows:

Source first met SUBJECT in September 1964 when MARTI was hired as a shipping clerk by Polly Perry Stores and went to work under Source's Immediate supervision. Source had only business contact with SUBJECT during the period of association, and had not seen MARTI since SUBJECT resigned HIS employment at Polly Perry in February 1965.

Source had no knowledge of SUBJECT'S personal background, education, residence or home life, except that SUBJECT was believed to be single and was attending school at night, further details unknown. Source was not certain but he seemed to recall SUBJECT once mentioning that HIS father, not further identified, operated a small grocery store. Source believed that SUBJECT'S employment at Polly Perry Stores was HIS first job, and HE left there to seek better employment but Source had no knowledge of where SUBJECT went to work.

MARTI was an excellent employee and HE got along well with HIS co-workers at Polly Perry. HE is highly intelligence and appears to have considerable leadership ability. Source knew nothing adverse concerning SUBJECT'S moral character, integrity, discretion, honesty, maturity, and financial responsibility. HE appeared to be emotionally stable, and manifested no undesirable personal habits whatever. SUBJECT was never heard to express any radical political views, and although Source did not know what HIS specific political views were, Wang had no reason to doubt or question SUBJECT'S loyalty to the United States. Source had no knowledge of SUBJECT'S organizational affiliations, foreign travels, business interest or relatives residing abroad. Source would gladly re-employ SUBJECT if the occasion arose. Source suggested that Allen Lee and Cora McLendon, former co-workers of SUBJECT as persons who would be knowledgeable of HIM.

Wang recommends that MARTI be favorably considered for a position of trust and responsibility with the United States Government.

4. REPORT OF FINDINGS

(LISTED EMPLOYMENT CO-WORKER) On 14 October 1968, Allan Lee, Assistant Buyer, Polly Perry Stores, 33-37 17th Street, New York, New York 10003, who resides at 3 West 123rd Street, New York, New York 10027, was interviewed at his place of employment concerning Manuel MARTI. Source who was a co-worker of SUBJECT from September 1964 to February 1965 stated substantially as follows:

Source first met SUBJECT in September 1964 when MARTI was hired as a chipping clerk by Polly Perry Stores, and he had daily business contact with SUBJECT until MARTI left Polly Perry in February 1965 in order to seek better paying employment. Source's contact with SUBJECT was limited to matters concerning the work at their place of employment, and Source had not seen SUBJECT since February 1965 when HE left Polly Perry.

Source had no knowledge of SUBJECT'S personal background, parents, siblings, education or residence. MARTI was attending school at night, further details unknown, and usually brought HIS books to the job so that HE could study during spare moments. HE appeared to be of Latin decent but spoke English fluently and without any accent.

SUBJECT was a quiet, well mannered, intelligent and cooperative employee. HE was always punctual in HIS attendance and appeared to get along well with HIS associates at work. HE seemed to be a very ambitious young man, and Source knew nothing adverse concerning SUBJECT'S moral character, integrity, discretion, honesty, or social habits. HE was a very competent employee, and demonstrated no signs of immaturity or emotional instability. SUBJECT was never heard to express any radical political views, and Source presumes that HE is loyal to the United States. Source had no knowledge of SUBJECT'S organizational affiliations, home life, foreign travels, business interests or relatives residing abroad. Source was unable to suggest anyone who may have knowledge of SUBJECT.

Lee recommends that MARTI be favorably considered for a position of trust and responsibility with the United States Government.

4. REPORT OF FINDINGS

(LISTED EMPLOYMENT CO-WORKER) On 14 October 1968, Cora McLendon, Clerk, Polly Perry Stores, 33-37 East 17th Street, New York, New York 10003, who resides at 769 Park Place, Brooklyn, New York 11216, was interviewed at her place of employment concerning Manuel MARTI. Source who was associated with SUBJECT at Polly Perry Stores from September 1964 to February 1965 stated substantially as follows:

Source first met SUBJECT in September 1964 when HE was hired as a shipping clerk at Polly Perry Stores and was associated with HIM as a co-worker at that firm until February 1965 when HE left the firm. Source's contact with SUBJECT was limited to an occasional greeting at their place of employment and daily observance of HIM on the job. Source had not seen SUBJECT since HE left Polly Perry in February 1965.

Source had no knowledge of SUBJECT'S personal background, education, residence, relatives, or other employment.

SUBJECT was a very quiet, respectable looking young man and HIS conduct on the job was above reproach. HE seemed to get along well with HIS co-workers and performed HIS assigned duties in a very satisfactory manner. Source knew nothing adverse concerning SUBJECT'S character, integrity, discretion, political sympathies, or financial responsibility. HE had no known difficulty with law enforcement agencies. SUBJECT was never known to make any radical political statements and Source had no reason to doubt or question HIS loyalty to the United States. Source had no knowledge of HIS organizational affiliations, foreign travels, business interest or relatives residing abroad. Source was unable to suggest anyone who may have knowledge of SUBJECT. McLendon declined to make any recommendation concerning SUBJECT'S suitability for assignment to a position of trust and responsibility with the United States Government because of insufficient knowledge.
