4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 24 October 1968, Ramona Rodriguez, Housewife, Apartment 4E, 905 East 167th Street, Bronx, New York, was interviewed in her residence concerning Manuel MARTI. Source who has known SUBJECT since 1951 stated substantially as follows:

Source met SUBJECT and HIS parents as neighbors in 1951 when Source moved into the apartment across from SUBJECT at 905 East 167th Street, Bronx, New York. Source became a close friend of SUBJECT'S mother and saw SUBJECT daily until HIS family moved from the building in 1965. Source continued to visit SUBJECT'S mother after 1965 and until her death in early 1967. Source had not seen SUBJECT since the funeral of HIS mother in 1967.

Source had no knowledge of SUBJECT'S birthplace since HE was approximately six years of age when they first met. Source knew SUBJECT'S parents as Manuel and Reyes Marti. HE has an older brother, Ivan, and a younger sister, Blanca. SUBJECT was brought up in a very respectable home, and HIS parents exercised very strict control over the children. SUBJECT graduated from high school in Bronx, New York, shortly before HE and HIS parents moved from the neighborhood, further details unknown. Source had no knowledge of SUBJECT'S employment.

SUBJECT is a quiet, friendly, serious-minded young man of excellent character and personal behavior. HE was never known to be adversely involved with law enforcement agencies. HIS parents were very strict and watchful over the upbringing of SUBJECT and HIS brother and they were not allowed to roam the streets or participate in any neighborhood gang activities. Most of SUBJECT'S free time from school was spent at home with HIS studies, and with HIS hobbies of stamp collection, and HIS pet birds and fishes. Source believed that SUBJECT'S father worked in a factory, further details unknown, and was never known to operate HIS own business. HIS parents were never heard to speak badly about the United States and its democratic institutions, and Source was of the opinion that SUBJECT was brought up as a loyal United States citizen. SUBJECT is a mature, emotionally stable young man, and because of HIS home training Source was of the opinion that HE would be financially responsible. SUBJECT was not known to have any organizational affiliations, nor to have traveled outside of the United States. HE is honest, trustworthy and dependable, and has manifested no undesirable social habits. Source suggested Luisa Perez, 905 East 167th Street, Bronx, New York, as a friend of SUBJECT'S family. She was unable to suggest other persons in the neighborhood who would have knowledge of SUBJECT since most of the people presently residing in the apartment building moved there since SUBJECT moved away in 1965. 43

4. REPORT OF FINDINGS

Rodriguez recommends that MARTI be favorably considered for a position of trust and responsibility with the United States Government.

AGENT'S NOTES: Source who had a closer relationship with SUBJECT and HIS family than her spouse, Atanacio Rodriguez, was interviewed in lieu of her spouse who was not available. It is believed that SUBJECT erroneously listed Source's husband as Antonio instead of Atanacio.
