4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 4 November 1968, a check of the Hagstrom's Maps of Manhattan and Bronx, New York City, failed to reveal the location of 201 Roebling Street, New York, New York, the address reflected for listed character reference Hugo Rivera on Manuel MARTI'S SPH, dated 1 August 1968; however, a check of the Brooklyn, New York Telephone Address Directory revealed the existence of a Roebling Street, and a telephone listing 384-0091 for Maria Rivera at 201 Roebling Street, Brooklyn, New York. Repeated telephone calls at different hours and over a period of days failed to elicit any response from the residents at that address.

(LISTED CHARACTER REFERENCE) On 12 November 1968, a physical check was conducted at 201 Roebling Street, Brooklyn, New York, in an attempt to locate Hugo Rivera, listed character reference of Manuel MARTI, with the following results:

Mrs. Kuechler, wife of the apartment building superintendent, was interviewed and stated that the family named Rivera who resided at the above address had moved away approximately one month ago, and she had no knowledge of their present address.

(LISTED CHARACTER REFERENCE) On 13 November 1968, a postal removal check was conducted at the United States Post Office, 271 Cadman Plaza East, Brooklyn, New York, with the assistance of Mr. Urcinola, Postal Inspector, concerning Maria Rivera, 201 Roebling Street, Brooklyn, New York, and revealed the following information:

A postal removal notice had been submitted from that address on 1 October 1968 for Hugo Rivera only, and the new address is 2020 Walton Avenue, Bronx, New York 10453.
