## 4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 3 November 1968, Juanita Reyes, 170 West 89th Street, New York, New York, telephone number 874-7986, possible listed character reference of Manuel MARTI, was contacted telephonically at her residence for the purpose of arranging an appointment for interview. In reponse to a query concerning her failure to respond to a courtesy letter which had been left at her residence on 1 November 1968, Reyes stated that she had no recollection of SUBJECT, and was waiting to contact her family in order to determine if any of them were acquainted with MARTI. After receiving a description of SUBJECT from the undersigned Reyes stated categorically that she was not acquainted with MARTI.
