4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 3 November 1968, a physical check was conducted at 810 Hunts Point Avenue, Bronx, New York, in an attempt to locate and interview Aleanso Ortiz, listed character reference of Manuel MARTI, who allegedly resided at the above address. A check of the mail boxes located in the building revealed no listing for Ortiz. The building superintendent, Mrs. Matos, was questioned and stated that she had never heard of MARTI.
