4. REPORT OF FINDINGS

(NEIGHBORHOOD CHECK) On 24 October 1968, the following residents of the apartment building located at 905 East 167th Street, Bronx, New York 10459, were contacted at their respective apartments in an attempt to locate neighbors knowledgeable of Manuel MARTI, who resided at the above address from 1946 to 1965, with results as indicated:

Bonita Rodriguez, who has resided in apartment 4C since 1966, stated that she had no knowledge of SUBJECT and HIS family, and could not suggest anyone in the neighborhood who might be acquainted with MARTI.

Simona Padron, Apartment 1C, stated that she had only been residing in the apartment building for approximately one year and had no knowledge of SUBJECT. She was unable to suggest the names of other individuals in the neighborhood who might have knowledge of SUBJECT.

Celia Robateau, Apartment 3C, stated that she had resided at that address for the past five years but had no knowledge of SUBJECT and HIS family, and could not suggest the names of other neighbors who might be acquainted with MARTI.

AGENT'S NOTE: Alexander Castillo, whose interview by undersigned agent is recorded in a separate Agent Report, this investigation, was the only competent source regarding SUBJECT who could be located in the neighborhood additional to listed character reference Ramona Rodriguez and the person suggested by Rodriguez as a developed character reference, Luisa Perez.
