4. REPORT OF FINDINGS

(LOCAL AGENCY) On 26 September 1968, the New York Office, Federal Bureau of Investigation (FBI), United States Department of Justice, 201 East 69th Street, New York, New York, furnished the following information concerning Manuel Marti, also known as Adrian Martes, Adrian Martes Aponte, Adrian Marti Apontes, Adrian Sotomayor and "Soto", SUBJECT'S father:

Attached hereto, original only, as EXHIBIT I, are the following ten FBI, New York, New York reports, file number 100-100474, subject: Adrian Sotomayor: Reports dated 30 January, 12 May, 26 August, and 29 October 1953; 19 November 1956; 11 April 1957; 16 April 1958; 27 April 1961; 2 May 1962 and 10 June 1964.

Note is made of the birth date of SUBJECT'S father, i.e., 2 April 1910, as appears in report dated 11 April 1957, as compared with date of birth listed on current request for information, i.e., 10 August 1910.

Attached reports are additional to those FBI reports on SUBJECT'S father already in possession of Military Intelligence.

AGENT'S NOTE: The request to the FBI for information on SUBJECT'S father indicated that the following FBI reports were in possession of Military Intelligence: San Juan report 13 August 1952; New York reports dated 16 April 1959, 12 April 1960, 23 May 1962, 9 June 1965, 22 June 1966 and 21 June 1967.
