(CASUAL SOURCE) On 6 October 1966, a records check conducted at Casual Source A-16, Oakland, California, in regard to SUBJECT revealed the following information:

Since 1960, HE has been active in demonstrations in the Bay Area of California. Participated in the San Francisco City Hall riots, against the execution of Caryl Chessman, sit-ins, and teach-ins.

1960 Visited Cuba and wrote favorably of Castro

1965 Member of Vietnam Day Committee

1966 Foreign news editor of Rampart Magazine

1966 Visited Cambodia

(CASUAL SOURCE) On 6 October 1966, Casual Source A-14, Oakland, California, informed that Robert SCHEER is a well-known individual in the Bay Area of California who usually supports all liberal political policies. HE has been active in free speech movements in Berkeley, California, has been a candidate for election to the US Congress, and is active in attempting to alter US policy toward Vietnam. There is no evidence that HE has ever attended a meeting of any organization that is considered subversive toward the US Government nor has HE been identified as a member of any such organization. HIS wife, Anne, is active in similar endeavors as SUBJECT.
