11. On 15 July 1969, S. F. REEVES, GS-8, SSAN: 261-50-7220, Shipment Planner, 3201st Transportation Squadron, Eglin AFB, Florida, advised Eglin AFB that a review of his files revealed a copy of a GBL, Nr F-0,648,922, dated 28 March 1969, with an attached DD Form 1149 (REQUISITION AND INVOICE/SHIPPING DOCUMENT), dated 13 March 1969, Requisition Nr FB2823 9073X100XXX, both of which he furnished to the writer. A review of these documents revealed that an outgoing shipment consisting of one box of small arms ammunition weighing 55 pounds and a box of captured enemy weapons, weighing 140 pounds, was shipped from AETL (ATEL), Eglin AFB, Florida 32542 (Mr. COOLEY/882-2328) to Sicily, 1655 Peachtree Street N.E., Atlanta, Georgia 30309, Attn: Mr. FRED BROWN. The DD Form 1149 reflects serial numbers for the 11 weapons as follows: 4514, 1300273, 35285, 68149, 12099391, 928231, 8414320, 12047120, 411564, 700867 and 930843.
