## 4. REPORT OF FINDINGS

(U) On 1 February 1972, the personnel records of C Team, 66th USA Artillery Detachment, Datteln, (IC8424), Federal Republic of Germany (FRG), APO New York 09078, were checked with the aid of FNU Kulesza, 1LT, 286-7 (2) (D) 48-0611, Team Commander, C Team, 66th USA Artillery Detachment, regarding the following persons and revealed the following information:

(U) Clyde E. Myers, PFC, 266-96-0932, arrived C Team 11 December 1968, departed unit on 8 November 1971 for assignment with 51st Infantry, Cralsheim (NV7843), FRG. Disqualified from nuclear weapons as part of 611-5 program because of use of drugs. Myers was engaged to Eva-Maria Dorka, Gelsinkirchen (LC6909), FRG, Bronner Strasse 22. Reference Agent Report dated 5 February 1972, Subject as above, interview of Robert Creed.

(U) Kulesza was unable to discover anyone by the name of Jackson or Julius, first or last name, that had ever been stationed at C Team. Reference Agent Report dated 5 February 1972, Subject as above, interview of Robert Creed.
