7. JOHN DEE JAY SPEAKS RUSSIAN, GERMAN, SPANISH AND ENGLISH. HE HAS EXPRESSED PRO CAS SEN IMEN S AND HAS SAID HE HAD BEEN O

MOSCOW, USSR, WHERE HE LEARNED TO SPEAK ENGLISH. HE CLAIMED TO HAVE A COUSIN OR NEPHEW WHO IS A MAJOR IN THE GERMAN DEMOCRATIC REPUBLIC (DDR) ARMY. HE ALLEGEDLY TRAVELS FREQUENTLY TO THE DDR AND HAS EXPRESSED A DESIRE TO RETURN HERE TO LIVE BECAUSE HE HAS AN UNCLE IN THE FEDERAL REPUBLIC OF GERMANY. HE IS EXTREMELY KNOWLEDGEABLE ABOUT THINGS PERTAINING TO THE MILITARY. HE KNEW THE EXACT DEPARTURE TIME, LOCATION, INTERMEDIATE STOPS, AND FINAL DESTINATION OF A RECENT CONVOY BOSS MISSION AS TO EXCHANGE. HE HEARS A SASCOM UNIT. JOHN AND JAY ASKED ROBERT H. CREED, INTERVIEWED IN PARA 4 TO BRING HIM SOME AIR AND ARMY BOOKS. ALL THE, JOHN, AND JAY WERE SOME AIR STORIES, NOTHING ABOUT NORAD OR CANRAC (SPECIAL AMMUNITIONS RECOGNITION AND AUTHENTICATION SYSTEMS).
