FOR WHOM HE HAD LOST RESPECT. THIS TENDENCY LED TO AN INCIDENT AT ROTC ADVANCED CAMP AT FORT RILEY, KANSAS, IN THE SUMMER OF 81, WHEN WHITE REFUSED TO OBEY A CADET'S ORDER (NO FURTHER INFORMATION), AND WAS ALMOST BOARDED OUT OF THE CAMP.  
7. (C) WHITE'S SERIOUSNESS, INTELLIGENCE, AND INTENSITY SEEMED THREATENING TO SOME CADETS AT KMCS. HE TENDED TO REMAIN ALOOF FROM HIS PEERS. ON TOP OF THIS, HIS POOR SKIN COMPLEXION, NERVOUS MANNERISMS, AND ERRATIC DRESS (ONE DAY - NEAT, THE NEXT DAY - SHABBY) MADE WHITE THE BUTT OF DERISION AND PRANKS AT KMCS. HE WAS OSTRACIZED AND UNIVERSALLY DISLIKED. HIS PEER RATING AT ROTC ADVANCED CAMP WAS REPORTED TO BE LOW.  
8. (C) WHITE TRIED HARD TO SUCCEED IN EVERYTHING HE DID. HOWEVER, HIS SELF-ESTEEM WAS CONSTANTLY BATTERED BY THE ATTITUDES OF HIS PEERS AND A STRING OF DISAPPOINTMENTS. DURING HIS FIRST YEAR AT KMCS HE GOT INTO SEVERAL FIGHTS WITH OTHER CADETS. ALSO, HIS GIRLFRIEND (NFI) BROKE OFF THEIR RELATIONSHIP, ALLEGEDLY UNDER PRESSURE FROM HER PARENTS. (WHITE PAPERED A MYRIAD OF PICTURES OF HER ON HIS DORMITORY WALL.) WHITE DATED SELDOM, IF AT ALL. ONE OF HIS INSTRUCTORS, A CAPTAIN DAVID, REPORTEDLY GAVE WHITE A ZERO FOR TURNING IN A PAPER LATE, BUT DID NOT PENALIZE OTHERS WHO HAD DONE SO, AS SEVERELY. CPT DAVID WAS THE TYPE OF PERSON WHO EITHER LIKED OR HATED OTHERS, AND IT SEEMED THAT HE DISLIKED WHITE INTENSELY FOR UNKNOWN REASONS.

1. (U) SOURCE HAD NO OBJECTION TO THE RELEASE OF HIS IDENTITY TO SUBJECT.

2. (U) ON 10 SEP 82, JOSEPH C. MERLINO, 027-54-4638, ZLT, USAR, DPOB: 26 APR 62, BOSTON, MA, COMPANY A, 2D BATTALION, 104TH INFANTRY MASSACHUSETTS ARMY NATIONAL GUARD, WAS INTERVIEWED AT THE UNIVERSITY OF MASSACHUSETTS CAMPUS, AMHERST, MA, CONCERNING SUBJECT. SOURCE PROVIDED SUBSTANTIALLY THE FOLLOWING INFORMATION: (MSG PARA 3 THRU 12

3. (U) MERLINO FIRST MET WHITE ON 28 AUG 80, WHEN BOTH ARRIVED AT KEMPER MILITARY SCHOOL & COLLEGE (KMCS), BOONVILLE, MISSOURI, AS FRESHMEN (PLEBES), ASSIGNED TO DIFFERENT COMPANIES. MERLINO'S LAST CONTACT WITH WHITE WAS ON ABOUT 26 SEP 81, TWO DAYS BEFORE WHITE DROPPED OUT OF KMCS THROUGHOUT ACADEMIC YEAR 80-81 AND DURING SEP 81. MERLINO SAW WHITE DAILY, USUALLY AT FORMATIONS, OCCASIONALLY IN CLASS, BUT MADE PERSONAL CONTACT ONLY ON ABOUT FIFTEEN OCCASIONS. THEY ALSO MET BRIEFLY AT THE AIRBORNE SCHOOL, FT BENNING, GEORGIA, IN JULY 1981. THEY WERE WELL ACQUAINTED, BUT WERE NOT CLOSE PERSONAL FRIENDS.

4. (C) MERLINO DID NOT KNOW OF WHITE'S FAMILY BACKGROUND OR FINANCIAL SITUATION, ALTHOUGH WHITE DID NOT APPEAR TO HAVE ANY FINANCIAL PROBLEMS. NOR DID MERLINO KNOW IF WHITE USED NARCOTICS OR ABUSED ALCOHOL. WHITE WAS PHYSICALLY HEALTHY AND FIT, BUT NOT ATHLETIC. HE DID NOT APPEAR TO HAVE ANY DEVIANT SEXUAL TENDENCIES OR HANG-UPS, TO INCLUDE HOMOSEXUALITY. WHITE WAS REPUTED TO BE A MORALLY STRAIGHT INDIVIDUAL WHO VALUED HIS OWN HONESTY AND INTEGRITY. HE WAS EXCEPTIONALLY BRIGHT, AND CONSISTENTLY EARNED HIGH GRADES IN ACADEMIC SUBJECTS AND MILITARY SCIENCE.

5. (C) WHITE WAS ALSO A VERY SERIOUS, EXTREMELY INTENSE, AND HIGHLY IDEALISTIC PERSON. HE WAS USUALLY MILD-MANNERED, BUT WOULD GET QUITE AGITATED DURING SERIOUS DISCUSSIONS. IN PAPERS HE WROTE AND DURING DISCUSSIONS IN HISTORY CLASS HE EARNESTLY DEFENDED THE MARXIST PHILOSOPHY OF EQUALITY. IN OTHER DISCUSSIONS HE REVEALED AN ADMIRATION FOR HOW ADOLF HITLER HARNESSSED THE ENERGIES AND NATIONALISM OF THE GERMAN PEOPLE. HOWEVER, WHITE DID NOT APPEAR TO BE PRO-NAZI OR ANTI-SEMITIC. IN FACT, HE SEEMED TO BE SYMPATHETIC TO MINORITY GROUPS IN THE U.S., AND THEIR BID FOR EQUALITY.

6. (C) WHITE NEVER SHOWED ANY DISLOYALTY TO THE U.S., ALTHOUGH DURING CONVERSATIONS HE WOULD CONSTRUCTIVELY CRITICIZE AND CRITIQUE BOTH AMERICAN SOCIETY AND THE SOVIET GOVERNMENT. HE TALKED SERIOUSLY AS THOUGH HE HAD HIS OWN PROGRAMS FOR IMPROVING THE LOT OF OTHER PEOPLE. WHITE NORMALLY RESPECTED SUPERIORS AND THEIR AUTHORITY, AS LONG AS THEY MADE SENSE TO HIM. BUT, HE WOULD BALK AT OBEYING SOMEONE

9. (C) AFTER WHITE'S NEAR FAILURE AT ROTC ADVANCED CAMP, HE WAS RE-CYCLED AT AIRBORNE SCHOOL FOR FAILING THE PT TEST. HOWEVER, HE RECOVERED AND COMPLETED THE COURSE. WHEN HE RETURNED TO KMSC IN SEP 81, HE WAS DEEPLY UPSET UPON LEARNING THAT HE WAS ONLY A CADET SERGEANT FIRST CLASS AND NOT AN OFFICER. WHITE WAS IN SOURCE'S COMPANY (SOURCE WAS A CADET MAJOR). ON ONE OCCASION, DURING LEADERSHIP LAB, SOURCE CORRECTED WHITE WHO WAS IMPROPERLY EXECUTING THE HIGH AND LOW CRAWLS. WHITE REACTED INDIGNANTLY AT FIRST; BUT AFTER SOURCE EXPLAINED WHAT HE DID WRONG, WHITE ADJUSTED AND CONTINUED TO PERFORM. ALSO IN SEP 81, ANOTHER CADET (NFI) TOOK ONE OF WHITE'S BOOKS FROM HIS ROOM. VIOLENTLY ANGRY, WHITE DRAPED TOILET PAPER ON THE CADET'S DORMITORY DOOR AND SET IT ON FIRE. SOURCE CAUGHT WHITE IN THE ACT OF SETTING THE BLAZE AND LAUGHING ABOUT IT. MERLINO VERBALLY CENSURED WHITE AND THREATENED TO GET HIM DISMISSED FROM KMSC. SHORTLY THEREAFTER, WHITE ADVISED THAT HE WANTED TO LEAVE SCHOOL. HE WAS COUNSELED BY COLONEL JOHNNY PARKER, SCHOOL COMMANDANT. PARKER ASKED SOURCE FOR HIS RECOMMENDATION. SOURCE SYMPATHIZED WITH WHITE BUT COULD NOT RECOMMEND HIM FOR A COMMISSION IN THE US ARMY BECAUSE OF HIS APPARENT IMMATURITY.

10. (C) AROUND 26 SEP 81, BEFORE WHITE LEFT KMSC, HE TOLD SOURCE HE WAS LEAVING THE SCHOOL. WHITE SAID HE DID NOT WANT TO BE AN OFFICER, BECAUSE HE WAS "FED UP WITH THE BULLSHIT AND THE ASS-KISSING". HE ADDED THAT HE WAS GOING TO ENLIST IN THE ARMY AND BECOME "THE BEST DAMN NCO HE COULD BE". BY HIS COMMENTS AND HIS TONE OF VOICE DURING THIS AND OTHER CONVERSATIONS, WHITE INDICATED THAT HE WASN'T GETTING WHAT HE DESERVED FROM SOCIETY. SOURCE WISHED HIM LUCK AND NEVER SAW OR HEARD FROM HIM AGAIN.

11. (C) SOURCE WAS NOT TOTALLY SURPRISED WHEN HE READ OF WHITE'S DEFECTION TO NORTH KOREA. IT SEEMED TO FIT IN WITH HIS PERSONALITY. SOURCE GUESSED THAT WHITE'S ACTION RESULTED FROM THE CULMINATION OF HIS DISAPPOINTMENTS. WHITE PROBABLY BECAME DISILLUSIONED WITH THE ARMY OR HIS UNIT AND HAD PROBABLY ENTERTAINED THOUGHTS ABOUT DEFECTING FOR SOME TIME. HOWEVER, IT WAS MOST LIKELY ONE PARTICULAR INCIDENT THAT PROMPTED HIM TO TAKE ACTION. WHERE ONCE WHITE WAS A FAILURE IN U.S. SOCIETY, HE GAINED NOTORIETY AND AN INTERNATIONAL AUDIENCE THROUGH HIS DEFECTION. SOURCE BELIEVED THAT THE TEXT OF THE REMARKS ATTRIBUTED TO WHITE BY THE GOVERNMENT OF NORTH KOREA SOUNDED LIKE WHITE'S WORDS AND MANNER OF SPEECH, AND COULD VERY WELL HAVE BEEN AUTHORED BY WHITE. AT LEAST THEY PARALLELED WHITE'S IDEALISTIC BUT NAIVE SOCIO-POLITICAL VIEWS.

HATCH, 2LT USAR, A NATIVE OF PENNSYLVANIA, WHO KNEW WHITE BETTER THAN ANYONE, CAPTAIN MICHAEL R. BASISTA, SGM JAMES MCKANE, AND MSG STEPHEN G. HINK.
