FOR RIO: SOME MEMBERS OF CHICOM DELEGATION TO THE SEVENTH CONGRESS OF INTERNATIONAL UNION OF ARCHITECTS (UIA) HELD HAVANA 29 SEPT - 3 OCT AFTERWARDS WENT MEXI TO ATTEND UIA GENERAL ASSEMBLY AND INTERNATIONAL SYMPOSIUM ON ARCHITECTURE. MEXI GROUP NOW SCHEDULED LEAVE MEXI 0100 HOURS 19 OCT FOR RIO. FOLLOWING BIO DATA ON THREE MEMBERS OF GROUP KNOWN TO BE MEXI:

RESEARCH SCHOLAR CHINA. CONVERSATION FRIENDLY AND INCLUDED DISCUSSION MAINLAND SITUATION. LIANG APPROACHED BY KUBARK CONTROLLED U.S. SINOLOGIST WHO WAS STUDENT LIANG AT YALE 1947. CONTACT WITH LIANG KNOWN TO OTHER CHICOMS IN DELEGATION, ALTHO LIANG LEFT ALONE WITH OUR MAN FOR HALF HOUR. LIANG ATTITUDE FRIENDLY BUT SEEMED TO FOLLOW PREARRANGED LINE AND LIANG PROFESSED COMPLETE BELIEF CHINESE COMMUNISM. LIANG CLAIMED CONTACT BETWEEN CHINESE AND AMERICAN "FRIENDS" CONSIDERED HIGHLY DESIRABLE BY CHINESE. CONTACTS WITH BOTH LIANG AND YANG LIMITED TO FRIENDLY DISCUSSIONS SINCE OPERATIONAL DISCUSSION DID NOT SEEM APPROPRIATE IN EITHER CASE.

3. WU'S BROTHER, U.S. CITIZEN, ARRIVING MEXICO 16 OCTOBER TO TALK WITH WU AND ASK HIM IF WISHES REMAIN IN FREE WORLD.

4. REQUEST **RIO** MONITOR ACTIVITIES GROUP BRAZIL AS FEASIBLE AND ATTEMPT DEVELOP FURTHER BIO AND ASSESSMENT DATA IF NATURAL ACCESS TO GROUP CAN BE FOUND. DO NOT RECOMMEND FORCED APPROACH TO ANY OF GROUP, SINCE OUR COVER FOR THIS ACTIVITY WEARING THIN AND THERE IS LONG RANGE GOAL OF FUTURE FOLLOW UP THESE CONTACTS WHEN APPROPRIATE ACCESS CAN BE ARRANGED.
